WHEREAS, the recognition was granted by NRC to **Delhi Institute of Management and Technology, Vill.- Kakra, Post- Muradnagar, Tehsil- Modinagar, Distt.- Ghaziabad, State- Uttar Pradesh** for B.Ed. Course vide order no. F.NRC/NCTE/F-7/UP-2817/2008/61629-61635 dated 10.09.2008 with an annual intake of 100 seats students from the academic session 2008-2009.

AND WHEREAS, the institution has submitted request letter dated 18.12.2015 to withdraw the recognition for B.Ed. course. The matter was considered in NRC in its 247th meeting and NRC decided that on the request of the institution the recognition of B.Ed. course be withdrawn under section 17 of NCTE Act, 1993.

NOW THEREFORE, in exercise of the powers vested under section 17(1) of NCTE Act, 1993, the Northern Regional Committee hereby withdraw the recognition granted to **Delhi Institute of Management and Technology, Vill.- Kakra, Post- Muradnagar, Tehsil- Modinagar, Distt.- Ghaziabad, State- Uttar Pradesh** for B.Ed. course on the grounds mentioned above with effect from the end of the academic session next following the date of communication of this order.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of sections 18 of NCTE Act, 1993 within 60 days from the date of this order. The following FDR's submitted by your institution is returned herewith in original.
