AND WHEREAS, the institution submitted an application received in the NRC office on 30.01.2018 requesting for change of status of the institution from **Women to Co-Ed**

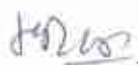
AND WHEREAS, the matter was placed before the NRC in its 280th meeting held from 06th to 07th February, 2018 and the Committee decided as under: -
