ORDER

WHEREAS in terms of Section **14(1)** of the NCTE Act, 1993 **Shri Guru Ram Rai (PG) College, Village - Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist. Dehradun, Uttarakhand** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **B.Ed Course of One year** duration with an annual intake of **100 (Hundred only)** students on **09.01.2006** and NRC granted recognition/permission to the institution for conducting **B.Ed. Course of one year duration with an intake of 100 students** vide Order No. F.NRC/NCTE/F-7/UR-86/13111-13117 dated 29.12.2006.

2. AND WHEREAS the inspection of the institution was conducted under **Section 17** on 13.6.2009. The Northern Regional Committee in its 143rd meeting held on 27-29th June 2009, after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, the Regional Committee had decided to issue Show Cause Notice under Section 17 of the NCTE Act, 1993. Accordingly SCN was issued to the institution on 3.7.2009.

3. AND WHEREAS the applicant institution had submitted representation on 17.7.2009. The original file of the institution as well as other documents and reply dated 17.7.2009 were considered by the Northern Regional Committee in its 146th meeting held on 5-7th August 2009 and the Committee had decided to withdraw the recognition to the said recognition. Accordingly Withdrawal order has been issued vide order No. F. NRC/NCTE/F-3/UR-86/2009/10413-19 dated 15.9.2009.

3. AND WHEREAS the institution had preferred an appeal on 18.08.2009 against the withdrawal order of NRC dated 15.9.2009 to the appellate authority. The appeal of the institutions was accepted and NRC's order dated 15.9.2009 was reversed with direction to NRC to grant recognition to the institution within 15 days vide order **dated 08.10.2009**.

4. NOW, THEREFORE, in exercise of the powers vested under Section **14(3) (a)** of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Shri Guru Ram Rai (PG) College, Village - Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist. Dehradun, Uttarakhand** for conducting **B.Ed of Secondary (Level) of One year** duration with an annual intake of **100 (Hundred only)** students from the academic session **2009-2010** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007.

5. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

6. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

7. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

8. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered

Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

10. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

11. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

12. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
