ORDER

CHANGE OF NAME OF THE INSTITUTION

WHEREAS, recognition was granted to the institution namely **Shri Guru Ram Rai (PG) College, Village-Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist-Dehradun, State-Uttarakhand** for conducting **B.Ed.** Course of one-year duration with an annual intake 100 students vide order No.NRC/NCTE/F-7/UR-86/13111-13117 dated **29.12.2006** and that for **M.Ed.** course of one year duration with an annual intake of 25 students from the academic session 2009-2010 vide order No. **NRC/NCTE/F-7/UR-119/12445-12451 dated 18.11.2009.**

2. **AND WHEREAS,** Revised Recognition Order, as per NCTE Regulations 2014, was issued to the institution vide NRC Order No. NRC/NCTE/UR-86/2015/115008-012 dated 08.06.2015 with an annual intake of students i.e. one basic unit of 50 students from the academic session 2015-2016 for B.Ed. course and for M.Ed. course vide order F.No./ NRC/NCTE/UR-119/2015/115013-18 dated 06.06.2015.

3. **AND WHEREAS,** the institution has requested for change of name of the institution vide letter dated 05.07.2017 and the matter was placed before NRC in its 272nd Meeting held on 06th to 07th July 2017, and the Committee decided as under: -

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and guidelines of NCTE published from time to time were carefully considered by Northern Regional Committee and the Committee observed the following: -

- NRC considered the letter of Shri Guru Ram Rai Education Mission received on 05.07.2017. NRC accepted the request of the Mission and decided that the name of the institution be read as "Shri Guru Ram Rai College of Education, Pathribagh, Dehradun" which is a constituent college of "Shri Guru Ram Rai University, Dehradun".

4. **AND WHEREAS,** the institution has submitted another letter dated 18.11.2025 received in NRC office on 02.12.2025 for issuance of communication as per decision of NRC taken in its 272nd meeting held on 6th to 7th July 2017 and the matter was placed before NRC in its 453rd Meeting (Vol-III) held on 11th & 12th December 2025, and the Committee decided as under:

"The file of the institution along with other related documents, NCTE Act 1993, NCTE Rules 1997, NCTE Regulations 2014, Standards Operating Procedure (SoP) & Guidelines issued by NCTE (HQ) from time to time were placed before the Northern Regional Committee and the Committee observed the following:

- The recognition was granted to the aforesaid institution for offering B.Ed. course of one year duration with an annual intake of 100 students vide Order dated 29.12.2006 followed by revised recognition order for B.Ed. course of two-year duration with an annual intake of 100 students i.e. two basic units of 50 students each vide Order dated 08.06.2015.

- The recognition was also granted to the aforesaid institution for offering M.Ed. course of one year duration with an annual intake of 25 students vide Order dated 18.11.2009 followed by revised recognition order for M.Ed. course of two-year duration with an annual intake of 50 students vide Order dated 08.06.2015.
- The institution has requested for change of name of the institution from Shri Guru Ram Rai College of Education, Pathribagh, Dehradun" which is a constituent college of "Shri Guru Ram Rai University, Dehradun".
- The Committee considered the reply of the institution in its 272nd Meeting held on 06th & 07th July, 2017 and permitted that the name of the institution be read as "Shri Guru Ram Rai College of Education" which is constituent college of "Shri Guru Ram Rai University" The Committee further noted that no communication has been sent by the office of NRC to the institution to this effect.

Hence, the Committee decided that a communication be issued to the institution as per decision of NRC taken in its 272nd Meeting held on 6th & 7th July, 2017 and the name of the institution be also updated on the NRC Website in the list of recognized institution."

5. NOW THEREFORE, in terms of above decision of NRC, the institution namely **Shri Guru Ram Rai (PG) College, Village-Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist-Dehradun, State-Uttarakhand** is hereby permitted to change its name as "**Shri Guru Ram Rai College of Education**" as a constituent College of "**Shri Guru Ram Rai University**" for conducting two units of the students B.Ed. & one unit of 50 students of M.Ed. course of two-year duration.
