ORDER


In terms of the powers contained in the Section 14(1) of the NCTE Act, 1993 Shiksha Bharti B.Ed. College, Kotla Khurd, Una, Himachal Pradesh was granted recognition by the NRC, NCTE, Jaipur for B.Ed. course of one year duration from the academic session 2002-2003 with an annual intake of 100 (One Hundred) only subject to fulfillment of conditions stipulated vide this office Order No. F.NRC/NCTE/F-3/HP-64/2002/8231-8238 dt. October 29, 2002.

2. WHEREAS, vide letter dt. 24.02.2004 the institution requested to change the address of the college from Kotla Khurd to Samoor Khurd, Una, HP.

3. AND WHEREAS, the matter was considered by the NRC and the Committee decided that the recognition granted to the institution for B.Ed. course granted earlier shall continue on usual conditions and thereafter, decided that the institution be permitted to shift to the new premises and the change of address may be communicated to all the concerned.

4. AND THEREFORE, the address of the college in future will be Shiksha Bharti B.Ed. College, VPO - Samoor Khurd, Tehsil - Bangana, Distt. - Una, Himachal Pradesh.


