ORDER

WHEREAS, Adarsa Educational Society, Maruthi Nagar, Kurnool District-518002, Andhra Pradesh had applied for grant of recognition to Sri Saraswathi College of Education, 9/99, Kalyanadurga Road, Azadnagar, Ananthpur-515004, Andhra Pradesh for Secondary (B.Ed) course of two years duration with an annual intake of 100 students. Recognition was granted to the institution on 27.08.2001.

AND WHEREAS, a Complaint was been received from Sri Raja Rao, Principal, Adarsha B.Ed College, Giddalur against Saraswathi B.Ed. College, Ananthpur, Andhra Pradesh, Sankar B.Ed. College, Kurnool and Adarsh B.Ed. College, Giddalur of Andhra Pradesh. He had informed the diversion of corpus fund paid by the correspondent towards three B.Ed colleges and three DIET colleges.

AND WHEREAS, the SRC in its 184th Meeting held on 26-27 October, 2009 considered the Complaint matter and decided to call for Affidavit from the Complainant and to call for remarks from the institution and the complainant.

AND WHEREAS, as per the decision of SRC, a letter was addressed to the institution on 08.12.2009 and a letter was issued to the complainant on 02.12.2009. The institution and complainant have not submitted reply even after the expiry of stipulated period.

AND WHEREAS, the SRC in its 193<sup>rd</sup> Meeting held on 21-22 June, 2010, noted that the institution has not replied to the letter dated 8.12.2009 addressed to the institution and it has also noted that the complainant has also not replied to the letter even after the expiry of stipulated period and it has decided to issue Notice to the institution under section 17 of NCTE Act on the following complaint:-

- 1 Correspondent of the above colleges sent totally two hundred bogus B.Ed candidates through counseling.
- 2 The management did not pay six months salary from 1<sup>st</sup> January 1995 to 1<sup>st</sup> July 1995.
- 3 The correspondent is not paying provident fund
- 4 The Correspondent is also not paying the salaries to the staff through Bank.

AND WHEREAS, as per the decision of SRC a Notice was issued on 27.07.2010. the institution had not submitted its written representation/documents.

AND WHEREAS, the SRC in its 211<sup>th</sup> Meeting held on 21<sup>st</sup>-23<sup>rd</sup> September, 2011 considered the non submission of notice reply and the committee has noted the matter.

AND WHEREAS, the institution had submitted a letter dated 21.02.2014 received in this office of SRC on 24.02.2014 stating that "... Adarsa Educational Society, Kurnool, started Sri Saraswathi College of Education at Anantapur NCTE, SRC, Bangalore accorded recognition for this college.

*Due to administrative differenties the society resolved to shift the college to Head Quarters of the Society, i.e. to Kurnool. Application is submitted in triplicate.*

In Kumool the managing body namely Adarsa Educational Society, already owned land and buildings. The copies of land documents, with land conversion and Ownership true translation approved building plan building completion certificate are enclosed herewith for your perusal.

As per the NCTE Regulation cited above I am herewith enclosing Demanded Draft for Rs. 40,000/- bearing No. 634287 dated. 15.02.2014 of Andhra Bank, Kumool to wards shifting fee.  
I request you to accord permission at the earliest to shift the college to Kurnool"

**AND WHEREAS**, the SRC in its 264<sup>th</sup> Meeting held on 01<sup>st</sup> – 03<sup>rd</sup> March, 2014 considered the matter, letter from the institution dated 21.02.2014 and decided and advised SRO to 1. Obtain all relevant documents; and, process for causing inspection. 2. To collect balance of Rs. 10,000/- towards the 'fee'.

**AND WHEREAS**, as per the decision of SRC, a letter was issued to the Institution on 20.03.2014 and the Institution submitted its reply on 21.04.2014

**AND WHEREAS**, the SRC in its 268<sup>th</sup> Meeting held on 4 – 5 June 2014, considered the reply of the Institution along with the original file, letter from the institution dated 21.04.2014, all the relevant documents of the institution submitted, decided and advised Southern Regional Office to await Notification of the new Regulations and to process it after.

**AND WHEREAS**, a letter dated 19.10.2014 of the Correspondent Adarsa Educational Society, Maruthi Nagar, Atmakur Road, Kurnool received by this office on 13.10.2014 & 17.10.2014 stating that:-

*"In our application dated 21.02.2014 we requested to accord permission for shifting the college from Anantapur to Kumool the Head Quarters of the Society, where in all facilities like land building Etc. for accommodation this college after shifting are available*

*In your letter cited 2<sup>nd</sup> above you directed the management to provide some more information. For this we sent the reply in our letter dated 15.04.2014.*

*Even after 9 months no action is taken on our request. The delay is causing lot of hardship for the management as the beginning of the academic year is fast approach. We request you to issue early favourable orders and oblige "*

**AND WHEREAS**, the institution submitted the certain documents along with Affidavit requesting to process the application as per Regulations 2014, on 30.12.2014.

**AND WHEREAS**, the Southern Regional Committee in its 276<sup>th</sup> meeting held during 7<sup>th</sup> to 9<sup>th</sup> January, 2015 considered the matter, reply of the Institution dated 30.12.2014 along with affidavit expressing their willingness to process their application as per Regulations 2014, also considered all the relevant documents of the institution, reply of the institution vide their letter dated 21.04.2014, and it was decided to serve Notice.

**AND WHEREAS**, the Southern Regional Committee in its 283<sup>rd</sup> meeting held during 02<sup>nd</sup> -03<sup>rd</sup> March, 2015 considered the matter and decided to "Issue SCN for deficiency in title to land at the new site. The land is shown as encumbered. Also Building Plan is very old". Before issuance of show cause notice (based in website information) has submitted reply to the notice on 25.03.2015, the institution

1. The land is encumbered:

No where in the two Ecs i.e. 787/15 and 788/15, it was shown as encumbered. The two Ecs were issued in the name of Adarsa Educational Society, Kumool. The details are shown against Sl.No. 10/14 for document No. 6663/92 in EC bearing No. 787/15 and against Sl.No. 11/15 for No. 4813/92 in EC No. 788/15. They are underlined marked in the certificate.

2. *Building plan is old:*

A stated in our letter Dt. 06.02.2015 the building plans were approved on 20.04.2002 and the same are enclosed. Any how the structural soundness certificate is enclosed to prove that the building is fit for running the college. As the issue is long pending for more then one year early orders are solicited.

**AND WHEREAS**, the Southern Regional Committee in its 285<sup>th</sup> meeting held during 17<sup>th</sup> April, 2015 considered the reply of the institution dated 25.03.2015 and has decided to Cause Inspection for Shifting.

**AND WHEREAS**, as per the decision of SRC, the inspection letter was addressed to the institution on 20.04.2015. The inspection of the institution was conducted on 25.04.2015 and the VT Report was received by this office on 27.04.2015.

**AND WHEREAS**, the Southern Regional Committee in its 286<sup>th</sup> meeting held on 30<sup>th</sup> April 2015, considered the visiting team report, VCD, relevant documents and it was decided to permit Shifting of premises for B.Ed.

**NOW THEREFORE**, permission is hereby accorded by SRC to **Sri Saraswathi College of Education, 9/99, Kalyanadurga Road, Azadnagar, Ananthpur-515004, Andhra Pradesh** to shift its premises to the new location / building at **Sri Saraswathi College of Education, Maruti Nagar Nandikotkur Road, Kurnool District-518002, Andhra Pradesh.**

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Further, the institution has submitted affidavit on 28.01.2015, as per regulations 2014 and the revised order for the academic year 2015-16 is under:

**ORDER**

**WHEREAS**, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure].Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

**2. AND WHEREAS**, the institution, **Sri Saraswathi College of Education, Maruti Nagar Nandikotkur Road, Kurnool District-518002, Andhra Pradesh** has by affidavit consented to come under New Regulations and sought for two basic units in **B.Ed** which require additional facilities

**3. AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017

**4. NOW THEREFORE**, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Sri Saraswathi College of Education, Maruti Nagar Nandikotkur Road, Kurnool District-518002, Andhra Pradesh** for conducting **B.Ed** programme of **two** years duration with an annual intake of **150** students each for three basic units from the academic session **2015-16** subject to fulfilment of the conditions mentioned herein before 31.10.2015

5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
