ORDER

WHEREAS, St. Ann's Educational Society, Doctor's Lane, Karimnagar, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE seeking permission to start Rousseau College of Elementary Teacher Education, Karimnagar Road, Sircilla, Karimnagar District -505301, Andhra Pradesh for Elementary (D.Ed) course.

AND WHEREAS, the recognition was granted to the institution on 26.08.2005 with a condition that the institution shall shift both B.Ed & D.Ed courses to its own premises /building within three years from the date of recognition of B.Ed College as the recognition for D.Ed is issued based on existence of B.Ed College and notification dated 01.01.2004 of NCTE. (in case the B.Ed/D.Ed course is started in rented premises).

AND WHEREAS, the institution has submitted its written representation on 26.12.2015 along with relevant documents. The letter stated as follow:

"I would like to bring to your notice the following information with respect to permanent building of our Rousseau College of Elementary Teacher Education Institution.

- 1. Rousseau college of Education, was granted recognition for B.Ed course of one year from the academic session 2002-2003 with an annual intake of 100 students (vide reference (1) cited above).*
- 2. During 2002-03 it was started in Sircilla in a rented building and subsequently we have constructed a permanent building in Venkataopally (V), Narsingapur, Boinpalli Mandal (which fall under Sircilla Revenue Division, Karimnagar Dist.) for which inspection was carried on 01.09.2010 at the permanent building itself and the recognition granted was continued and the same was communicated in the letter cited above under reference iii.*
- 3. During 2005-06. we have submitted an application to start D.Ed course of two years with the name as "Rousseau College of Elementary Teacher Education Institution" with an annual intake of 50 students Accordingly after due inspection NCTE has granted permission to start D.Ed course from 2005-06. (vide reference cited above).*
- 4. After construction of permanent building even D Ed course is being run in permanent building located at Venkataopally (V). Narsingapur. Boinpalli Mandal (which fall under Sircilla Revenue Division. Karimnagar Dist) along with B Ed course.*

5. Since then D.Ed course is running and inspections and correspondence with respect to D.Ed and B.Ed course is happening at Venkataopally(V), Narsingapur, Boinpalli Mandal.
6. Even Inspection for additional Intake in D.Ed for 2014-15 was also conducted at our permanent building at Venkataopally, and the permanent address is mentioned in the communication received for grant of additional intake through letter cited above under reference V.

From all the above communications NCTE made to the institution it can be understood that Rousseau College of Elementary Teacher Education Institution has a permanent building structure and it is running the course since 2010 in the permanent building structure.

In view of the above I request you to include the permanent address of Rousseau College of Elementary Teacher Education Institution in the first FR and reissue the FR orde with permanent address which is mentioned below (The same address is mentioned as well in the order given for D.Ed-AI).

AND WHEREAS, the SRC in its 298th meeting held on 08th – 10th January, 2016 considered the matter, letter dated 30.06.2015 and other relevant documents of the institution and decided as under:

1. They have D.El.Ed., D.El.Ed(A.I) and B.Ed.
2. B.Ed and D.El.Ed were shifted without permission
3. Subsequently, D.El.Ed(A.I) was allowed at the 'new' premises after inspection.
4. There has so far been no formal inspection for the shifting. Verify the records check that all requirements have been fulfilled for all the three programmes in accordance with the norms under the 2014 Regulations,
5. If every thing is all right, collect the 'unpaid' fees, and issue a formal order recognizing the shifting.

NOW THEREFORE, permission is hereby accorded to Rousseau College of Elementary Teacher Education, Karimnagar Road, Sircilla, Karimnagar District - 505301, Andhra Pradesh to shift its premises to new location/building at Rousseau College of Elementary Teacher Education, Khasara/Plot No.384, Venkataraopally Village, Narsingapur Post, Boinpally Taluk, Karimnagar District-505524, Andhra Pradesh.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.
