RESTORATION ORDER

WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Vijaya College of Physical Education, Khasara/Plot No. 1/4/F, 1/4/G, 1/4/C, 1/4/D, 1/4/B, Kunna Village & Post, Vijayawada Rural Taluk, Krishna District – 521212, Andhra Pradesh vide order no. F.No.SRCAPP35/B.P.Ed./AP/2014 - 15/57379 dated 03.03.2014 for conducting B.P.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2014-2015.


2. **AND WHEREAS**, on promulgation of NCTE Regulation 2014, the institution has submitted an affidavit to come under new Regulations vide dated 14.02.2015. Thereafter, the Revised Provisional Recognition Order was issued to the institution on 19.05.2015 for conducting B.P.Ed. course of two years duration with an annual intake of **one basic unit of 100 students (two sections of 50 students each)** from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 408th Meeting held on 02nd March 2022 considered the matter and decided to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulation, 2014 at the earliest in order to ascertain the compliance of NCTE Regulation, 2014. Accordingly, as per the decision of SRC, Show Cause Notice was issued to the institution on 13.03.2024. The institution did not submit reply to the Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 441st meeting held on 04th August, 2024 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 22.08.2024. The institution has submitted its reply on 17.09.2024.

5. **AND WHEREAS**, the SRC in its 459th Meeting held on 08th – 09th May, 2025 considered the matter and decided to withdraw the recognition order. Accordingly, as per the decision of SRC a withdrawal order No. F.SRC/NCTE/SRCAPP35/B.P.Ed/459th Mtg./AP/2025/148053 dated 15.05.2025 was issued to the institution.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No. 89-211/E-369096/2025 Appeal/8th Meeting, 2025 APPLSRC202515126/131934 dated 20.08.2025 appeal remand back the case to src with a direction to **verify the NEC submitted by the appellant institution and decision taken accordingly. the appellant institution is directed to forward to the SRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the SRC to take further necessary**



action as per the NCTE Regulation, 2024, guidelines and amendments issued from time to time.

7. **AND WHEREAS**, the institution has submitted its representation alongwith the required documents (NEC) which was received in SRC on 04.09.2025. The SRC in its 471st meeting held on 11th – 12th September, 2025 has considered the matter and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

- **The documents submitted by the institution in response to the order of Appellate Authority dated 20th August 2025 found to be satisfactory.**

Hence, the Committee decided that the Restoration order be issued to the Institution namely Vijaya College of Physical Education, 1/4F, 1/4/g, 1/4/c, 1/4/d, 1/4/b, Kunna, Loyabat Road, Vijayawada Rural Taluk, Krishna, Andhra Pradesh for B.P.Ed., programme of 01 basic unit of 100 students".

8. **NOW THEREFORE**, as per the decision of SRC, this order is issued permitting the institution i.e., Vijaya College of Physical Education, 1/4F, 1/4/g, 1/4/c, 1/4/d, 1/4/b, Kunna, Loyabat Road; Vijayawada Rural Taluk, Krishna, Andhra Pradesh for B.P.Ed. programme for 1 basic unit of 100 students is restored.


