



CONTINUATION ORDER

WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, **Venkata Rathna College of Education, No. 87/1364, Maruthi Nagar, Kallur, Kurnool District - 518002, Andhra Pradesh** vide order No. F.SRO/NCTE/B.Ed./2007-2008/17113 dated 18.01.2008 for conducting **B.Ed.** programme of one-years duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit on 22.01.2015 for its willingness of two units in B.Ed. course and adherence provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**
3. **AND WHEREAS**, the SRC in its 388th Meeting held on 14th -15th September, 2020 and the Committee directed the Regional Director, SRC to issue a Show Cause Notice u/s 17 of NCTE Act, 1993 to all the Regional Director, SRC to issue a Show Cause Notice u/s 17 to NCTE Act, 1993 to all the institutions wherein recognition was accorded by the SRC under Regulations, 2014 with the direction to submit all requisite documents coupled with latest approved staff list from concerned affiliating bodies. In case no reply or part reply to SRC is received by the SRC office. The RD is also authorized to issue Final SCN in all such matters." Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 07.01.2021. The institution has not submitted reply to the Show Cause Notice
4. **AND WHEREAS**, the SRC in its 411th Meeting held on 23rd -24th May, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 02.06.2022. The institution has submitted reply received on 05.07.2022.
5. **AND WHEREAS**, the SRC in its 435th meeting held on 03rd April, 2024 considered the matter and decided to issued last reminder letter to the institution. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 19.04.2024. The institution has submitted reply on 23.04.2025.
6. **AND WHEREAS**, the SRC in its 459th meeting held on 08th – 09th May, 2025 considered the matter and decided as under: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following decision: -



The staff list submitted by the institution for B.Ed Programme, in response to SCN be got verified from the Registrar of the concerned University."

7. Accordingly, as per the decision of SRC a letter was issued to the Registrar, Rayalaseema University on 15.05.2025 to verify the staff list.

8. The Registrar, Rayalaseema University Verify of staff list vide e-mail dated 11.09.2025 & 13th September 2025 has submitted the reply.

9. **AND WHEREAS**, the SRC in its 473rd Meeting held on 30th September 2025 considered the matter and decided as under: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-


- *The SCN reply submitted by the institution on 23.04.2025 found to be satisfactory.*

*Hence, the Committee decided that the **continuation order** be issued to the Institution namely **Venkata Rathna College of Education, No. 87/1364, Maruthi Nagar, Kallur, Kurnool District-518002, Andhra Pradesh for B.Ed programme of two years duration with an annual intake of 2 basic unit (100 students).**"*

10. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Venkata Rathna College of Education, No. 87/1364, Maruthi Nagar, Kallur, Kurnool District - 518002, Andhra Pradesh** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **2 basic units of 50 students each** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.



12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.


16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
