CONTINUATION / SHIFTING ORDER

WHEREAS, the recognition U/Section-14 of NCTE Act, 1993 was granted to the institution namely, **Janna Bharathi College of Education, Dharmavaram Revenue Division, Dodagatta Road, Ananthpur District, Andhra Pradesh** vide Order No. F.AP/NEW/B.ED/153/SRO/NCTE/2002-2003/6125 dt 03.03.2003 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2002-2003.

2. **AND WHEREAS**, on promulgation of NCTE Regulation 2014, the institution has submitted an affidavit to come under new Regulations vide dated 21.01.2015. Thereafter, the Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (Two Basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the institution has submitted an application along with processing fee of Rs. 1,77,000/- only for shifting of premises on 05.07.2025 and the institution has submitted revalidated Demand Draft of Rs. 1,77,000/- only.

4. **AND WHEREAS**, SRC in its 480th Emergent Meeting held on 16th – 17th December, 2025 considered the matter and decided to constitute online VT.

5. **AND WHEREAS**, the online inspection was conducted on 05.01.2026 and VT Report downloaded from VT Portal 05.01.2026 for its consideration. The SRC in its 481st Meeting held on 08th January, 2026 considered the VT Report and decided as follows:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

- 1. The institution has applied for shifting of premises on 05.07.2025 along with all required documents.*
- 2. The inspection of the institution was conducted on 05.01.2026 on the new building of the institution. As per VT report, the facilities available in the institution are up to mark as per NCTE Rules & Regulations.*
- 3. Apart from above, the institution fulfils all conditions mentioned in the Revised Recognition Order i.e. 1 year B.Ed to 2 years B.Ed program as per NCTE Regulations 2014.*



In view of the above, the SRC decided to grant permission to the institution for Shifting of its premises from Jnana Bharathi College of Education, Dharmavaram Revenue Division, Dodagatta Road, Ananthapur District, Andhra Pradesh to Jnana Bharathi College of Education, Survey No. 132/2, Pusalapadu Village, Bestavaripeta Mandal, Prakasam District – 523334, Andhra Pradesh.

Further, the Recognition Continuation order for B.Ed. programme with annual intake of 100 students (Two Basic units) be issued to the institution.”

6. NOW THEREFORE, this order is issued permitting the institution i.e., Jnana Bharathi College of Education, Dharmavaram Revenue Division, Dodagatta Road, Ananthapur District, Andhra Pradesh to shift its building/premises at new address at Jnana Bharathi College of Education, Survey No. 132/2, Pusalapadu Village, Bestavaripeta Mandal, Prakasam District – 523334, Andhra Pradesh. Further, the Recognition Continuation order for B.Ed. programme with annual intake of 100 students (Two Basic units) subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

8. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.



- e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
11. The institution shall make available the list of students admitted on its official website.
12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.


