EXTRAORDINARY
ORDER FOR SHIFTING OF PREMISES

WHEREAS, the recognition U/Section-14 of NCTE Act, 1993 was granted to the institution namely, **J.V.R.R. Memorial College of Education, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal – 518502, Andhra Pradesh** run by **J.V.R.R. Educational Society, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal, Andhra Pradesh - 518502** vide Order No. F.AP/B.Ed./Ext/44/SRO/NCTE/2000-2001/1595 dt. 16.08.2000 for conducting B.Ed. course of one year duration with an annual intake of 160 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 09.01.2025 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.06.2025 for conducting B.Ed. Programme of two years duration with an annual intake of 150 (three basic units of 50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, the SRC in its 428th meeting held on 25th August, 2023 considered the matter and decided to issue Continuation Order. Accordingly, as per the decision of SRC a Continuation Order No. F.No.SRC/NCTE/APS00282/B.Ed/AP/2023/143268-143272 dated 31.08.2023 was issued to the institution for 3 basic units of (150 students).

4. **AND WHEREAS**, the institution has submitted an application dated 02.05.2025 for shifting of premises from **J.V.R.R. Memorial College of Education, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal – 518502, Andhra Pradesh** to **J.V.R.R. Memorial College of Education, Survey No. 46/A, Kandulapuram Village, Cumbum Mandal, Prakasam District – 523333 Andhra Pradesh**

5. **AND WHEREAS**, the SRC in its 473rd meeting held on 30th September 2025 considered the matter and decided to constitute online VT. The online inspection was conducted on 23.10.2025 and VT report received on 24.10.2025.

6. **AND WHEREAS**, the SRC in its 483rd Meeting held on 17th January, 2026 considered the matter and decided as under:-

The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. The institution has applied for shifting of premises on 02.05.2025 along with all required documents.



2. The inspection of the institution was conducted on 24.10.2025 in the new building of the institution. The facilities available in the institution are as per NCTE Act, Rules & Regulations.

In view of the above, the SRC has decided to grant permission to the institution for shifting of its premises from J.V.R.R. Memorial College of Education, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal – 518502, Andhra Pradesh to J.V.R.R. Memorial College of Education, Survey No. 46/A, Kandulapuram Village, Cumbum Mandal, Prakasam District – 523333 Andhra Pradesh for B.Ed. programme.

7. **NOW THEREFORE**, this order is issued permitting the institution i.e., J.V.R.R. Memorial College of Education, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal – 518502, Andhra Pradesh to shift its building/premises at new address at **J.V.R.R. Memorial College of Education, Survey No. 46/A, Kandulapuram Village, Cumbum Mandal, Prakasam District – 523333 Andhra Pradesh** for conducting B.Ed. programme of two years duration with an annual intake of 03 basic units of 50 students each (Total Intake of 150 Students).
