EXTRAORDINARY
ORDER FOR SHIFTING OF PREMISES

WHEREAS, the recognition U/Section-14 of NCTE Act, 1993 was granted to the institution namely, **Rainbow College of Education, Plot No.10/A, Thimminaidupalem Village & Post, Tirupathi Taluk and City, Chittoor District – 517507, Andhra Pradesh** run by **Universal Educational and Rural Development Society, Plot No. 16/518-2, Devuni Cuddapah Road, Kadapa Village and Post, Kadapa Taluk & City, Kadapa District – 516001, Andhra Pradesh** vide Order No. F. SRO/SRCAPP14768/B.Ed./AP/2016/84838 dt. 02.05.2016 for conducting B.Ed. course of two-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, the institution has submitted an application for shifting of premises from Rainbow College of Education, Plot No.10/A, Thimminaidupalem Village & Post, Tirupathi Taluk and City, Chittoor District – 517507, Andhra Pradesh to **Rainbow College of Education, Survey No. 310, Enamadala Village, Prathipadu Mandal, Guntur District – 522019, Andhra Pradesh.**

3. **AND WHEREAS**, the SRC in its 458th meeting held on 29th April, 2025 considered the matter and decided to constitute online VT. The online inspection was conducted on 16.09.2025 and VT report received on 23.09.2025.

4. **AND WHEREAS**, the SRC in its 483rd Meeting held on 17th January, 2026 considered the matter and decided as under:-

“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. The institution has applied for shifting of premises on 03.09.2024 along with all required documents.
2. The inspection of the institution was conducted on 16.09.2025 in the new building of the institution. The facilities available in the institution are as per NCTE Act, Rules & Regulations.

In view of the above, the SRC has decided to grant permission to the institution for shifting of its premises from Rainbow College of Education, Plot No.10/A, Thimminaidupalem Village & Post, Tirupathi Taluk and City, Chittoor District – 517507, Andhra Pradesh to Rainbow College of Education, Survey No. 310, Enamadala Village, Prathipadu Mandal, Guntur District – 522019, Andhra Pradesh for B.Ed. programme.”



5. **NOW THEREFORE**, this order is issued permitting the institution i.e., Rainbow College of Education, Plot No.10/A, Thimminaidupalem Village & Post, Tirupathi Taluk and City, Chittoor District – 517507, Andhra Pradesh to shift its building/premises at new address at **Rainbow College of Education, Survey No. 310, Enamadala Village, Prathipadu Mandal, Guntur District – 522019, Andhra Pradesh** for conducting B.Ed. programme of two years duration with an annual intake of two basic units of **50 students each (Total Intake of 100 Students)**.
