EXTRAORDINARY
ORDER FOR SHIFTING OF PREMISES

WHEREAS, the recognition U/Section-14 of NCTE Act, 1993 was granted to the institution namely, **Viswavani College of Education, 22/24, Fort (Near Ramalayam), Nandyal – 518501, Andhra Pradesh** vide Order No. F.AP/B.Ed/Ext/46/SRO/NCTE/2000-2001/1524 dated 09.08.2000 for conducting B.Ed. course of one year duration with an annual intake of 160 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 29.01.2025 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 14.05.2025 for conducting B.Ed. Programme of two years duration with an annual intake of 150 (three basic units of 50 students each) from the academic session 2015.16.

3. **AND WHEREAS**, the SRC in its 438th meeting held on 03rd June, 2024 considered the matter and decided to issue Continuation Order. Accordingly, a Continuation Order No. F.SRC/NCTE/AOSO0578/B.Ed./AP/2024/145060-145064 dated 21.06.2024 was issued to the institution for 3 basic units.

4. **AND WHEREAS**, the SRC in its 421st Meeting held on 10th February, 2023 has considered the matter and decided to issue Withdrawal Order to the institution. Accordingly, as per the decision of SRC, Withdrawal Order vide order no. F.SRC/NCTE/AOSO0578/B.Ed./{AP}/2023/141208-141212 dt. 20.02.2023 was issued to the institution for B.Ed. programme.

5. **AND WHEREAS**, the institution had filed a WP. No. 30364 of 2023 in the Hon'ble High Court of Andhra Pradesh at Amaravati, whereby the Hon'ble High Court vide its order dt. 23.11.2023

6. **AND WHEREAS**, the SRC in its 438th meeting held on 03rd June, 2024 considered the matter and decided to issue Continuation order. Accordingly, as per the decision of SRC a Continuation order No. F.SRC/NCTE/AOSO0578/B.Ed./AP/2024 /145060-145064 dated 21.06.2024 was issued to the institution for 3 basic units

7. **AND WHEREAS**, the institution has submitted an application dated 31.07.2025 for shifting of premises from **Viswavani College of Education, 22/24, Fort (Near Ramalayam), Nandyal – 518501, Andhra Pradesh** to **Viswavani College of Education, Survey No. 254/6 to 255/3C, Chinthalapudi Village, Ponnur Mandal, Guntur District – 534460, Andhra Pradesh.**



8. **AND WHEREAS**, the SRC in its 459th meeting held on 08th – 09th May, 2025 considered the matter and decided to constitute online VT. The online inspection was conducted on 16.09.2025 and VT report received on 17.09.2025.

9. **AND WHEREAS**, the SRC in its 483rd Meeting held on 17th January, 2026 considered the matter and decided as under:-


The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. The institution has applied to shift premises on 31.07.2024 along with all required documents.
2. The inspection of the institution was conducted on 16.09.2025 in the new building of the institution. The facilities available in the institution are as per NCTE Act, Rules & Regulations.

In view of the above, the SRC has decided to grant permission to the institution for shifting of its premises from Viswavani College of Education, 22/24, Fort (Near Ramalayam), Nandyal – 518501, Kurnool District, Andhra Pradesh to Viswavani College of Education, Survey No. 254/6 to 255/3C, Chinthalapudi Village, Ponnur Mandal, Guntur District – 534460, Andhra Pradesh for B.Ed. programme.

10. **NOW THEREFORE**, this order is issued permitting the institution i.e., Viswavani College of Education, 22/24, Fort (Near Ramalayam), Nandyal – 518501, Kurnool District, Andhra Pradesh to shift its building/premises at new address at **Viswavani College of Education, Survey No. 254/6 to 255/3C, Chinthalapudi Village, Ponnur Mandal, Guntur District – 534460, Andhra Pradesh** for conducting B.Ed. programme of two years duration with an annual intake of 03 basic units of 50 students each (Total Intake of 150 Students).
