WHEREAS, the recognition U/Section-14 of NCTE Act, 1993 was granted to the institution namely, **Nagasatyanarayana College of Education, Plot No. 169, 10 Bollavaram, Nandikotkur - Village & Post, Nandikotkur Taluk, Kurnool District – 518401, Andhra Pradesh** run by **MER Educational Society, Plot No. 169, Main Road, 10 Bollavaram, Nandikotkur - Village & Post, Nandikotkur Taluk, Kurnool District – 518401, Andhra Pradesh** vide Order No. F. SRO/SRCAPP15029/B.Ed./AP/2016/83473 dt. 05.04.2016 for conducting B.Ed. course of two-year duration with an annual intake of 100 students from the academic session 2016-2017.

2. **AND WHEREAS**, the institution has submitted an application dated 24.04.2025 for shifting of premises from **Nagasatyanarayana College of Education, Plot No. 169, 10 Bollavaram, Nandikotkur - Village & Post, Nandikotkur Taluk, Kurnool District – 518401, Andhra Pradesh** to **Nagasatyanarayana College of Education, Survey No. 762-A1B, Gudluru Village, Gudluru Mandal, SPSR Nellore District – 523281, Andhra Pradesh.**

3. **AND WHEREAS**, the SRC in its 459<sup>th</sup> meeting held on 08<sup>th</sup> – 09<sup>th</sup> May, 2025 considered the matter and decided to constitute online VT. The online inspection was conducted on 29.09.2025 and VT report received on 29.09.2025.

4. **AND WHEREAS**, the SRC in its 483<sup>rd</sup> Meeting held on 17<sup>th</sup> January, 2026 considered the matter and decided as under:-

“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. The institution has applied for shifting of premises on 24.04.2025 along with all required documents.
2. The inspection of the institution was conducted on 29.09.2025 in the new building of the institution. The facilities available in the institution are as per NCTE Act, Rules & Regulations.

**In view of the above, the SRC has decided to grant permission to the institution for shifting of its premises from Nagasatyanarayana College of Education, Plot No. 169, 10 Bollavaram, Nandikotkur Village & Post, Nandikotkur Taluk, Kurnool District – 518401, Andhra Pradesh to Nagasatyanarayana College of Education, Survey No. 762-A1B, Gudluru Village, Gudluru Mandal, SPSR Nellore District – 523281, Andhra Pradesh for B.Ed. programme.**
