EXTRAORDINARY
ORDER FOR SHIFTING OF PREMISES

WHEREAS, the recognition U/Section-14 of NCTE Act, 1993 was granted to the institution namely, **Deekshitha B.Ed. College, Plot No. 550, 551, 555A, Sajjaladinne Village & Post, Tadipatri Taluk, Anantapur District – 515411, Andhra Pradesh** vide Order No. F. SRO/SRCAPP14595/B.Ed./AP/2016/83763 dtd. 11.04.2016 for conducting B.Ed. course of two-year duration with an annual intake of 100 students from the academic session 2016-2017.

2. **AND WHEREAS**, the SRC in its 413th meeting held on 22nd – 23rd August, 2022 considered the matter and decided to issue Continuation Order. Accordingly, as per the decision of SRC a Continuation Order No. F.SRC/NCTE/SRCAPP14595/B.Ed./AP/2022/134373-134377 dated 31.08.2022 was issued to the institution for 2 basic units of (100 students).

3. **AND WHEREAS**, the institution has submitted an application dated 08.07.2025 for shifting of premises from Deekshitha B.Ed. College, Plot No. 550, 551, 555A, Sajjaladinne Village & Post, Tadipatri Taluk, Anantapur District – 515411, Andhra Pradesh to **Deekshitha B.Ed. College, Survey No. 313/211, 6A, Oguru Village, Kandukur Mandal, SPSR Nellore District – 523105, Andhra Pradesh.**

3. **AND WHEREAS**, the SRC in its 380th Emergent meeting held on 16th – 17th December, considered the matter and decided to constitute online VT. The online inspection was conducted on 29.12.2025 and VT report received on 30.12.2025.

4. **AND WHEREAS**, the SRC in its 483rd Meeting held on 17th January, 2026 considered the matter and decided as under:-

“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. The institution has applied for shifting of premises on 08.07.2025 along with all required documents.
2. The inspection of the institution was conducted on 30.12.2025 in the new building of the institution. The facilities available in the institution are as per NCTE Act, Rules & Regulations.

In view of the above, the SRC has decided to grant permission to the institution for shifting of its premises from Deekshitha B.Ed. College, Plot No. 550, 551, 555A, Sajjaladinne Village & Post, Tadipatri Taluk, Anantapur District-515411, Andhra

Pradesh to Deekshitha B.Ed. College, Survey No. 313/211, 6A, Oguru Village, Kandukur Mandal, SPSR Nellore District – 523105, Andhra Pradesh for B.Ed. programme.”

5. **NOW THEREFORE**, this order is issued permitting the institution i.e., Deekshitha B.Ed. College, Plot No. 550, 551, 555A, Sajjaladinne Village & Post, Tadipatri Taluk, Anantapur District – 515411, Andhra Pradesh to shift its building/premises at new address at Deekshitha B.Ed. College, Survey No. 313/211, 6A, Oguru Village, Kandukur Mandal, SPSR Nellore District – 523105, Andhra Pradesh for conducting B.Ed. programme of two years duration with an annual intake of two basic units **of 50 students each (Total Intake of 100 Students).**
