ORDER FOR SHIFTING OF PREMISES

WHEREAS, the recognition U/Section-14 of NCTE Act, 1993 was granted to the institution namely, "Sree Vyshnavi B.Ed. College", No. 1-564, Janda Street No. 498, Gooty Village and Mandal, Anantapur – 515401, Andhra Pradesh vide Order No. F.No.APSO9644/B.Ed/AP/2011/30626 dt. 15.05.2025 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2012-2013.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 18.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units of 50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, the SRC in its 405th meeting held on 13th – 14th December, 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, Withdrawal Order No. F.SRO/NCTE/APS09644/B.Ed/AP/2021/129767 dtd. 31.12.2021 was issued to the institution.

4. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide Order No. F.No.89-86/E-247135/2022 Appeal/8th Meeting, 2022 dtd. 16.11.2022 on remanded back the case of institution. The institution vide letter dated 23.11.2022 & 23.04.2025 submitted reply to the appeal remand back order.

5. **AND WHEREAS**, the SRC in its 459th meeting held on 08th – 09th May, 2025 considered the matter and decided to issue Continuation Order. Accordingly, as per the decision of SRC a Continuation Order No. F.SRC/NCTE/APS09644/B.Ed./459th Mtg./AP/2025/148038-148042 dated 15.05.2025 was issued to the institution for 2 basic units of (100 students).

6. **AND WHEREAS**, the institution has submitted an application dated 26.05.2025 for shifting of premises from Sree Vyshnavi B.Ed. College, No 1-564, Janda Street, No. 498, Gooty Village and Mandal, Anantapur-515401, Andhra Pradesh to Sree Vyshnavi B.Ed. College, Survey No. 82/5, Pamuru Village, Pamuru Mandal, Prakasam District, Andhra Pradesh – 523108.

7. **AND WHEREAS**, the SRC in its 480th Emergent meeting held on 16th – 17th December 2025 considered the matter and decided to constitute online VT. The online inspection was conducted on 22.01.2026 and VT report received on 22.01.2026.

8. **AND WHEREAS**, the SRC in its 485th Meeting held on 04th February 2026 considered the matter and decided as under:-

“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. Inspection was conducted on 22.01.2026 for shifting premises on the new building of the institution.
2. Visiting Team report received on 22.01.2026.

In view of the above, the SRC has decided to grant permission to the institution for shifting of its premises from Sree Vyshnavi B.Ed. College, No 1-564, Janda Street, No. 498, Gooty Village and Mandal, Anantapur-515401, Andhra Pradesh to Sree Vyshnavi B.Ed. College, Survey No. 82/5, Pamuru Village, Pamuru Mandal, Prakasam District, Andhra Pradesh - 523108 for B.Ed programme.”

9. **NOW THEREFORE**, this order is issued for permitting the institution i.e., Sree Vyshnavi B.Ed. College, Plot No 1-564, Janda Street, No. 498, Gooty Village and Mandal, Anantapur-515401, Andhra Pradesh to shift its building/premises at new address at **Sree Vyshnavi B.Ed. College, Survey No. 82/5, Pamuru Village, Pamuru Mandal, Prakasam District, Andhra Pradesh - 523108** for conducting B.Ed. programme of two years duration with an annual intake of 02 basic units of 50 students each (Total Intake of 100 Students).
