ORDER FOR SHIFTING OF PREMISES

WHEREAS, the recognition U/Section-14 of NCTE Act, 1993 was granted to the institution namely, "Sri Lakshmi Venkateswara College of Education", Plot No. 376, Panchalingala Village Post Office, Kurnool Taluk & City, Kurnool district-518004, Andhra Pradesh vide Order No. F.SRO/SRCAPP3281/B.Ed./AP/2016/84052 dtd. 12.04.2016 for conducting B.Ed. course of two-year duration with an annual intake of 100 students from the academic session 2016-2017.

AND WHEREAS, the institution has submitted an application dated 30.07.2025 for shifting of premises from Sri Lakshmi Venkateswara College of Education, Plot No. 376, Panchalingala Village Post Office, Kurnool Taluk & City, Kurnool district-518004, Andhra Pradesh to Sri Lakshmi Venkateswara College of Education, Survey No. 43, Bestavaripeta Village, Bestavaripeta Mandal, Prakasam District, Andhra Pradesh - 523334.


3. AND WHEREAS, the SRC in its 473rd Meeting held on 30th September, 2025, considered the matter and decided to constitute online VT. The online inspection was conducted on 04.11.2025 and VT report received on 07.11.2025.

4. AND WHEREAS, the SRC in its 483rd Meeting held on 17th January, 2026 considered the matter and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. Inspection was conducted on 04.11.2025 for shifting of premises on the new building of the institution.
2. Visiting Team report received on 07.11.2025.
3. Final Show Cause Notice was decided on 17.01.2026.
4. The institution submitted its reply on 23.01.2026 based on minutes uploaded on the website of NCTE.

In view of the above, the SRC has decided to grant permission to the institution for shifting of its premises from Sri Lakshmi Venkateswara College of Education, Plot No. 376, Panchalingala Village Post Office, Kurnool Taluk & City, Kurnool district-518004, Andhra Pradesh to Sri Lakshmi Venkateswara College of Education, Survey No. 43, Bestavaripeta Village, Bestavaripeta Mandal, Prakasam District, Andhra Pradesh - 523334 for B.Ed programme."
