

from the academic year 2004-2005 under Regulation 5(e) of the NCTE Regulations 1995, subject to the following conditions:-

- (1) No grant-in-aid shall be sought from Government for running the proposed college; it shall be subject to permanently unaided policy of the State Government. The institutions shall give an undertaking to Government to this effect at the time of sanctioning affiliation based on the recognition to be granted by the NCTE-SRC.
- (2) The institution shall provide adequate infrastructure, staff etc., as per the norms and standards, prescribed by the National Council for Teachers Education and also the affiliating University;
- (3) The institution shall abide by the orders/rules of the State Government and the statutes and regulations of the affiliating University issued from time to time with regard to admission policy and recruitment of staff to the institution etc;
- (4) The institution shall collect 'Tuition fee' and 'Other fees' as prescribed by the State Government from time to time. The amount collected shall be utilized by the Institution in accordance with rules;
- (5) The management should start the institution only after obtaining recognition from the National Council for Teacher Education under Section 14 of the NCTE Act, 1993.

### ORDER

In terms of Section 14(1) of the NCTE Act, 1993 AI-Meezan Educational Association, Hubli, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to AI-Meezan Educational Association's B.Ed College, Highlands, Anandnagar Road, Old Hubli-580024, Dharwad District, Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2005-06 with an annual intake of 100 students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
  - a. The institution has acquired the land for setting up the teacher education institution.
  - b. The institution has constructed the building for conducting the course on the above mentioned land.
  - c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
  - d. The institution has selected the Principal and Seven lecturers for the said course and the list of faculty members has been approved by the affiliating University.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to AI-Meezan Educational Association's B.Ed College, Highlands, Anandnagar Road, Old Hubli-580024, Dharwad District, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.
  - a. The institution will ensure that Principal and Seven faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.
