CONTINUATION ORDER

**WHEREAS** the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely, "Dr. Penubala Penchalaiah College of Education," Plot No. 2177, Rly Koduru, Kadapa – 516101, Andhra Pradesh vide Order No. F.No./SRCAPP461/B.Ed/AP/2011-12/31568 dtd. 31.10.2011 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2012-2013.

2. **AND WHEREAS**, on promulgation of NCTE Regulation 2014, the institution has submitted an affidavit to come under new Regulations vide dated 02.02.2015. Thereafter, the Revised Provisional Recognition Order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 388<sup>th</sup> Meeting held on 14<sup>th</sup> – 15<sup>th</sup> September, 2020 considered the matter and decided to issue Show Cause Notice. Accordingly, a show Cause Notice was issued to the institution on 03.08.2023. The institution did not submit reply to Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 429<sup>th</sup> Meeting of SRC held on 11<sup>th</sup> October, 2023 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, Final Show Cause Notice was issued on 20.10.2023. The institution submitted its reply on 14.11.2023.

5. **AND WHEREAS**, the SRC in its 431<sup>st</sup> Meeting held on 10<sup>th</sup> January, 2024 considered the and decided to issue last reminder letter. Accordingly, a letter was issued to the institution on 25.01.2024. The institution has submitted their reply on 07.10.2025.

6. **AND WHEREAS**, the SRC in its 485<sup>th</sup> Meeting held on 04<sup>th</sup> February, 2026 considered the matter and decided as under: -

*"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -*

1. A letter was issued to the institution on 25.01.2024 for seeking clarification on some points.
2. In response to the above, the institution submitted its clarification on 07.10.2025.

***In view of the above, the SRC has decided to Continue the Recognition of the Institution. Accordingly, Continuation order be issued to the institution for B.Ed. programme with annual intake of 100 students."***

**7. NOW THEREFORE,** this order is issued permitting the institution i.e., **"Dr. Penubala Penchalaiah College of Education", Plot No. 2177, Rly Koduru, Kadapa – 516101, Andhra Pradesh** for continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **2 basic units of 100 students.**

**8.** Further, the institution is required to fulfil all such other requirements as may be prescribed by NCTE as well as other regulatory bodies like UGC, affiliating body/University, State Government concerned etc. as applicable.

**9.** The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

**10.** The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter-alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

**11.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

**12.** The institution shall make available the list of students admitted on its official website.

**13.** The institution shall fill the information on GIS Portal on the NCTE Website.



If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
