CONTINUATION ORDER

WHEREAS the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely, "Sanjeeva Reddy College of Physical Education", Perumantra Post, West Godavari – 534124, Andhra Pradesh vide Order No. F.No. F.SRO/NCTE/B.P.Ed/2007-2008/12456 dtd. 03.10.2007 for conducting B.P.Ed. course of one-year duration with an annual intake of 50 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulation 2014, the institution has submitted an affidavit to come under new Regulations vide dated 09.01.2015. Thereafter, the Revised Provisional Recognition Order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two section of 50 students each) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue Show Cause Notice. Accordingly, a show Cause Notice was issued to the institution on 19.02.2019. The institution has submitted its reply vide letter dated. 02.03.2019.

4. **AND WHEREAS**, the SRC in its 412th Meeting of SRC held on 05th – 06th July, 2022 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, Final Show Cause Notice was issued on 26.07.2022. The institution did not submit reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 438th Meeting held on 03rd June, 2024 considered the and decided to issue last reminder letter. Accordingly, a letter was issued to the institution on 21.06.2024. The institution has submitted its reply received on 16.01.2026.

6. **AND WHEREAS**, the SRC in its 486th Meeting held on 04th February 2026 considered the matter and decided as under: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. A letter was issued to the institution on 21.06.2024 for seeking clarification on some points.
2. In response to the above, the institution submitted its clarification on 07.10.2025.



In view of the above, the SRC has decided to Continue the Recognition of the Institutions. Accordingly, Continuation order be issued to the institution for B.P.Ed. programme with annual intake of 100 students (1 basic unit) & D.P.Ed. programme with annual intake of 50 students (1 basic unit)."

7. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Sanjeeva Reddy College of Physical Education, Perumantra Post, West Godavari – 534124, Andhra Pradesh** for Continuation of recognition for **B.P.Ed. programme** for two years duration with an annual intake of **1 Basic Unit of 100 Students**.

8. Further, the institution is required to fulfil all such other requirements as may be prescribed by NCTE as well as other regulatory bodies like UGC, affiliating body/University, State Government concerned etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter-alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.

13. The institution shall fill the information on GIS Portal on the NCTE Website.



If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
