RESTORATION ORDER

WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Vennela College of Elementary Teacher Education, S.No. 131/O, 132, Hyderabad Road, Anamtharam Village, Bhongir Taluka & Town, Nalgonda – 508116, Andhra Pradesh (Now Telangana) vide order no. F.No.SRCAPP1288/D.El.Ed/AP/2012/45802 dated 03.09.2012 for conducting D.El.Ed. course of two year' duration with an annual intake of 50 students from the academic session 2012-2013.

2. AND WHEREAS, the recognition of the institution was withdrawn by SRC vide order dt. 16.05.2025 on the grounds of non submission of PAR for the Academic Session 2021-2022 and 2022-2023.

3. AND WHEREAS, aggrieved by the order of SRC, the institution preferred an Appeal, and the Appellate Authority vide order dt. 26.09.2025 has set aside the order of SRC and remanded back the matter to SRC for fresh consideration in accordance with the directions specified above. The decision of Appellate Authority is quoted below :-

"After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to set aside the impugned order dt. 16.05.2025 and remand back the case to southern Regional Committee (SRC) for fresh consideration in accordance with the directions specified hereinabove. The Appellate institution is further directed to forward to the Regional Committee, within fifteen (15) days of receipt of this order, the documents submitted along with the appeal, whereupon the Regional Committee shall take further necessary action strictly in accordance with law and in light of the directions contained herein."

4. AND WHEREAS, the institution has not submitted any representation. The SRC in its 474th meeting held on 03.10.2025 has considered the matter and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

- *The recognition of the institution was withdrawn by SRC for D.El.Ed. Course vide order dt. 16.05.2025 on the grounds of non-submission of PAR for the Academic Session 2021-2022 and 2022-2023.*
- *Aggrieved by the order of SRC, the institution preferred an Appeal, and the Appellate Authority vide order dt. 26.09.2025 has set aside the order of SRC and remanded back the matter to SRC for fresh consideration in accordance with the directions specified in the order.*

The Committee has decided in terms of order dated 26.09.2025 passed by Appellate Committee, the said Recognition of the institution be restored for D.El.Ed course with an annual intake of 50 students (One unit) until fresh withdrawal order is passed. Concerned affiliating body be informed accordingly.

Further, the institution is directed to resubmit PAR upon reopening of the PAR Portal in accordance with prescribed standard operating Procedure, and the Regional Committee shall thereafter take a reasoned decision in conformity with the provision of the NCTE Act, 1993, the NCTE Regulation, 2014 and guidelines issued from time to time."

8. NOW THEREFORE, as per the decision of SRC, this order is issued permitting the institution i.e., Vennela College of Elementary Teacher Education, S.No. 131/O, 132, Hyderabad Road, Anamtharam Village, Bhongir Taluka & Town, Nalgonda – 508116, Telangana for D.El.Ed. programme for 1 basic unit of 50 students is restored.
