RESTORATION ORDER

WHEREAS, the recognition u/s 14/15 of NCTE Act, 1993 was granted to the institution namely, SR D.Ed. College, Plot/Khasara No. 222/A1, 222/A2, 222/B, 224 & 225, NRT Road, Brahmanapallo Village, Vinukonda Post, Taluk & City, Guntur District – 522647, Andhra Pradesh run by The Vivekananda Vidya Samstha Society, Plot No. 6-56, Main Bazaar Street, Vinukonda Village & Post, Vinukonda Taluk & City, Guntur District – 522647, Andhra Pradesh for D.El.Ed. & D.El.Ed.-Addl. programme as per following details:-

- (i) The SRC vide Order No F.SRO/NCTE/D.Ed/2006-2007/995 dtd. 08.04.2005 for conducting D.El.Ed. course of two-year duration with an annual intake of 50 students from the academic sessions 2006-2007.
- (ii) The SRC vide Order No. F.No.SRCAPP1805/D.Ed.-AI/2013-14/57209 dated 28.02.2014 for conducting D.El.Ed-AI programme of two-year duration with an annual intake of 50 students (one unit) from the academic sessions 2014-2015.
- (iii) The SRC vide Order No. SRO/NCTE/SRCAPP2442/D.El.Ed.-AI/AP/2016-2017/82922 dated 03.03.2016 for conducting D.El.Ed-AI programme of two-year duration with an annual intake of 100 students (Two Units) from the academic sessions 2016-2017.

2. **AND WHEREAS**, a letter No.RC.No.359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for deracination order in respect of 188 Pvt. D.El.Ed. College in A.P. since the said management of Pvt. D.El.Ed. College have made admission into the D.El.Ed. Course during academic year 2018-19 on their own in violation of Government.

3. **AND WHEREAS**, the SRC in its 397th Meeting held on 25th – 26th March, 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order was issued to the institution on 12.04.2021.

4. **AND WHEREAS**, aggrieved by the withdrawal order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide Order No. 89-161/E-185147/2021 Appeal/18th Meeting, 2021 Appeal No. APPLSRC202114032 dated

02.09.2021 appeal remand back the order appealed against. The institution has submitted written presentation vide letter dated 22.11.2021 & 16.08.2022.

5. **AND WHEREAS**, the institution filed Writ Petition no. 26225 of 2022 titled as "SR D.Ed. College vs The State of Andhra Pradesh and ors" before the Hon'ble High Court of Andhra Pradesh.

6. **AND WHEREAS**, the institution has submitted an affidavit dated 09.02.2026. The SRC in its 493rd Meeting held on 08th April, 2026 considered the matter and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The institution has submitted a representation/affidavit dated 09.02.2026 seeking issuance of restoration order.

The Committee considered the Order No. 89-161/E-185147/2021 Appeal/18th Meeting, 2021 Appeal No. APPLSRC202114032 dated 02.09.2021 passed by Appellate Authority, NCTE whereby the matter was remanded back to SRC and the Order dated 12.07.2025 passed by the Hon'ble High Court of Andhra Pradesh at Amaravati in Writ Petition no. 26225 of 2022 titled as "SR D.Ed. College vs State of Andhra Pradesh and ors." and other available records and communications, the Committee decided as under:

Restoration order be issued to the Institution for the D.El.Ed, D.El.Ed.-AI & D.El.Ed-AI. programme with annual intake of 200 students (50+50+100)."

7. **NOW THEREFORE**, in view of the above order passed by appellate authority the status of SR D.Ed. College, Plot/Khasara No. 222/A1, 222/A2, 222/B, 224 & 225, NRT Road, Brahmanapallo Village, Vinukonda Post, Taluk & City, Guntur District – 522647, Andhra Pradesh for D.El.Ed. & D.El.Ed.-Addl. programme for (4 units) of (50+50+100) 200 students is restored.
