**ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 The Vivekananda Vidya Samstha Society, Plot No. 222/A1, 222/A2, 222/B, NRT Road, Brahmanapalli Village, Vinukonda Post, Taluk & City, Guntur District - 522 647, Andhra Pradesh has applied for grant of recognition to SR D.Ed College, Plot/Khasara No. 222/A1, 222/A2, 222/B, 224 and 225, NRT Road, Brahmanapalli Village, Vinukonda Post, Taluk & City, Guntur District - 522 647, Andhra Pradesh for D.Ed-AI course online on 12.12.2012 for two years duration under Section 14 (1) of the NCTE Act, 1993 and received in the Southern Regional Committee NCTE on 17.12.2012.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Southern Regional Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc., for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to SR D.Ed College, Plot/Khasara No. 222/A1, 222/A2, 222/B, 224 and 225, NRT Road, Brahmanapalli Village, Vinukonda Post, Taluk & City, Guntur District - 522 647, Andhra Pradesh for conducting D.Ed-AI course of two years duration with an annual intake of 50 students from the academic session 2014-15 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
  - V. Minority Certificate from the Principal Secretary, Department of Education, Government of Andhra Pradesh to be submitted within 3 months from the date of issue of this order.
2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
3. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

4. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
- Sanctioned programmes along with annual intake in the institution;
  - Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
  - Name of faculty members who left or joined during the last , quarter;
  - Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - Fee charged from students;
  - Available infrastructural facilities;
  - Facilities added during the last quarter;
  - Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - The institution shall be free to post additional relevant information, if it so desires
  - Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.
5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
