WHEREAS, St. Anns Educational Society, Plot No. 384, Vemulawada Road, Venkatraopally Village, Narsingapur Post, Boinpally Village, Karimnagar District – 505524, Andhra Pradesh has applied for grant of recognition to Rousseau College of Elementary Teacher Education Institution, Khasara/Plot No. 384, Venkatraopally Village, Narsingapur Post, Boinpally Taluk, Karimnagar District – 505524, Andhra Pradesh has made an application for D.Ed-AI Course to Southern Regional Committee, NCTE, Bangalore on 05.10.2011.

AND WHEREAS, the recognition was granted to the institution on 18.05.2013 with an annual intake of 50 students from the academic session 2014-15.

AND WHEREAS, the institution filed court case in the Hon'ble Supreme Court of India, New Delhi. The Hon'ble Court in W.P. No. 492 of 2013 stating that "...direct that the recognition granted by the formal order dated 18th May, 2013 will apply for the academic session 2013-2014 and from 2014-2015.

AND WHEREAS, a corrigendum was issued to the institution on 13.09.2013 for 2013-14.

AND WHEREAS, the institution has submitted written representation on 14.01.2016. The SRC in its 298th meeting held on 08th – 10th January, 2015 considered the institutions written representation and it has decided as under;

1. They have D.Ed., D.Ed(A.I) and B.Ed.
2. B.Ed and D.Ed were shifted without permission
3. Subsequently, D.Ed(A.I) was allowed at the 'new' premises after inspection.
4. There has so far been no formal inspection for the shifting. Verify the records check that all requirements have been fulfilled for all the three programmes in accordance with the norms under the 2014 Regulations,
5. If every thing is all right, collect the 'unpaid' fees, and issue a formal order recognizing the shifting.


NOW THEREFORE, permission is hereby accorded to Rousseau College of Elementary Teacher Education Institution, Khasara/Plot No. 384, Venkatraopally Village, Narsingapur Post, Boinpally Taluk, Karimnagar District – 505524, Andhra Pradesh to shift its premises to new location/building at Rousseau College of Elementary Teacher Education Institution, Venkatraopally Village, Narsingapur Post, Boinpally Mandal, Karimnagar District – 505524, Telangana for D.Ed-AI course.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
