RESTORATION ORDER

WHEREAS the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely, **Sri Sanjeev College of Education, Plot/Khasara No. 63/1, Lingasugur Village, Post, Taluk & City, Raichur District, Karnataka-584122** vide Order No. F.SRO/SRCAPP15146/B.Ed./KA/2016/84599 dtd. 24.05.2016 for conducting **B.Ed.** course of two-year duration with annual intake of one basic unit of 50 students from the academic sessions 2016-2017.

2. **AND WHEREAS**, the SRC in its 403<sup>rd</sup> Meeting held on 18<sup>th</sup> & 19<sup>th</sup> October, 2021 considered to issue Continuation Order. Accordingly, as per the decision SRC, Continuation Order No. F.SRO/NCTE/SRCAPP15146/B.Ed./KA/2021/128982 dtd. 01.01.2021 was issued to the institution.

3. **AND WHEREAS**, the recognition of the institution was withdrawn by SRC vide order dt. 01.06.2025 on the grounds of non-submission of PAR for the Academic Session 2021-2022 and 2022-2023.


4. **AND WHEREAS**, aggrieved by the order of SRC, the institution preferred an Appeal, and the Appellate Authority vide order dt. 27.08.2025 has set aside the order of SRC and remanded back the matter to SRC for fresh consideration in accordance with the directions specified above.

5. **AND WHEREAS**, the institution has submitted representation vide letter dated 04.11.2025.

6. **AND WHEREAS**, the SRC in its 474<sup>th</sup> Meeting held on 03<sup>rd</sup> October, 2025 considered the Court matter and decided as under:-

*"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -*

- *The recognition of the institution was withdrawn by SRC for B.Ed. course vide order dt. 01.06.2025 on the grounds of non-submission of PAR for the Academic Session 2021-2022 and 2022-2023.*



- Aggrieved by the order of SRC, the institution preferred an Appeal, and the Appellate Authority vide order dt. 27.08.2025 has set aside the order of SRC and remanded back the matter to SRC for fresh consideration in accordance with the directions specified in the order.
- The institution vide representation dated 04<sup>th</sup> September 2025 has submitted the representation.

**The Committee has decided in terms of order dated 27.08.2025 passed by Appellate Committee, the said Recognition of the institution for B.Ed course with an annual intake of 50 students (One unit) be restored until fresh withdrawal order is passed. Concerned affiliating body be informed accordingly.**

**Further, the institution is directed to resubmit PAR upon reopening of the PAR Portal in accordance with prescribed standard operating Procedure, and the Regional Committee shall thereafter take a reasoned decision in conformity with the provision of the NCTE Act, 1993, the NCTE Regulation, 2014 and guidelines issued from time to time."**

**7. NOW THEREFORE, in view of the above order passed by appellate authority the status of Sri Sanjeev College of Education, Plot/Khasara No. 63/1, Lingasugur Village, Post, Taluk & City, Raichur District, Karnataka-584122 for B.Ed. programme for 1 basic unit of 50 students (Total intake = 50 students) is restored.**
