RESTORATION ORDER

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely, “**Browns College of Elementary Education, S.No. 559, Ammapalem Village, Thanikella Post, Konijerla Taluk, Khammam District – 507305, Telangana** run by **CP Brown Educational Society, Ammapalem Village, Thanikella Post, Konijerla Taluk, Khammam District – 507305, Telangana** vide Order No. F.SRC/NCTE/D.Ed/2005-2006/2279 dated 05.08.2005 for One Basic Unit of 50 students from the academic session 2005-2006 and subsequently vide Order No. F.No.SRCAPP866/D.El.Ed.-AI/AP/2012/45992 dtd. 10.09.2012 for conducting **D.El.Ed.-Addl.** course of two-year duration with an annual intake of **(One Unit) 50 students** from the academic session 2012-2013.

2. **AND WHEREAS**, the recognition of the institution was withdrawn by SRC vide order No. NCTE/2025/SRC/PAR/ORDER/SRCAPP866 dated 17.05.2025 on the grounds of non-submission of PAR for the Academic Session 2021-2022 and 2022-2023.

3. **AND WHEREAS**, against, the withdrawal order dated 17.05.2025 the institution has filed Writ Petition bearing No. 5821/2026 before Hon'ble High Court of Delhi titled as “**Browns College of Elementary Education Versus NCTE & others**” whereby the Hon'ble High Court vide Order dated 29.04.2026 to permit the petitioner to participate in the counselling session for the academic session 2025-2026.

4. **AND WHEREAS**, the SRC in its 496th Meeting held on 12th – 13th May, 2026 considered the matter and decided as under:-

“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. *The petitioner Institution filed a W.P(C) No. 5821/2026 and CM APPL.28643/2026 before the Hon'ble High Court of Delhi. The Hon'ble Court vide its order dated 29.04.2026 disposed of the writ petition with the following directions:*



"5. Accordingly, the present writ petitions is allowed, holding that the directions passed by the Coordinate Bench in paragraphs No. 12 to 16 in the judgment of Teachers Training College Mirza (supra) shall apply to the petitioner, including the direction to permit the petitioner to participate in the counselling session for the academic session 2025-26.


6. The above directions are subject to verification by the National Council for Techer Education (NCTE)."

2. The petitioner Institute shall be governed as per Hon'ble High Court of Delhi Order passed on 15.12.2025 and all the directions shall be applicable on the Petitioner Institute.

Keeping in view of the above the SRC decided as under: -

- 1. Restoration order be issued to the Institution for the D.El.Ed., D.El.Ed.-Al. programme with an annual intake of 50 (Existing) + 50 (Addl Intake) total intake of 100 students.*
- 2. The name of the Institution may also be updated on the website of the NCTE in the list of recognised institutions and a letter be written to the Registrar of the concerned affiliating university and the State Government.*

5. NOW THEREFORE, in view of the above order passed by Hon'ble High Court of Delhi the status of **"Browns College of Elementary Education", S.No. 559, Ammapalem Village, Thanikella Post, Konijerla Taluk, Khammam District – 507305, Telangana for D.El.Ed.-Addl. programme for (One Unit) of 50 students** is restored and now, total intake of (50+50) 100 students is granted for recognition.
