

AND WHEREAS, the Committee in its 197th meeting held on 13th-14th October 2010 considered the VT report Dt. 17.09.2010 of the institution, VCD and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting to new / permanent premises as mentioned above.

NOW, THEREFORE, the institution is permitted to shift from **Sterling Road, Nungambakkam, Chennai-600034, Tamilnadu** to **New permanent building at Loyola College Campus, Sterling Road, Nungambakkam, Chennai-600034, Tamilnadu** for conducting B.Ed course of one year duration with an annual intake of 100 students.
