**REVISED RESTORATION ORDER**

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely, Nauman College of Elementary Teacher Education, Sy. No. 374, Steet No. 09, Kodad Village and Post, Nalgonda District – 508206, Telangana run by Nauman Educational Society, Street No. NH.09, Kodad Village and Post, Nalgonda District – 508206, Telangana vide Order No. F.SRO/SRCAPP1718/D.El.Ed/AP/2015/63622 dtd. 28.04.2015 for conducting D.El.Ed. course of two-year duration with an annual intake of 50 students from the academic session 2015-2016.

2. AND WHEREAS, the recognition of the institution was withdrawn by SRC vide order No. NCTE/2025/SRC/PAR/ORDER/SRCAPP1718/151589 dated 15.07.2025 on the grounds of non-submission of PAR for the Academic Session 2021-2022 and 2022-2023.

3. AND WHEREAS, the petitioner Institution filed a W.P(C) No. 8241/2026 before the Hon'ble High Court of Delhi. The Legal Counsel Sh. Anuj Kapoor vide his email dated 17.06.2026 informed that the Hon'ble Court has allowed the writ petition on 17.06.2026 as per order dated 15.12.2025 passed in W.P.(C)5369/2025.

4. AND WHEREAS the SRC in its 504<sup>th</sup> Meeting held on 17<sup>th</sup> June, 2026 considered the matter and decided as under:-

*The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -*

1. *The petitioner Institution filed a W.P(C) No. 8241/2026 before the Hon'ble High Court of Delhi. The Legal Counsel Sh. Anuj Kapoor vide his email dated 17.06.2026 informed that the Hon'ble Court has allowed the writ petition on 17.06.2026 as per order dated 15.12.2025 passed in W.P.(C)5369/2025.*

**Keeping in view the above the SRC decided as under: -**

1. *Restoration order be issued to the Institution for the D.El.Ed. programme with an annual intake of 50 students.*
2. *The institution is permitted to participate in the counselling for academic session 2025-26 and admit students for the said academic session.*

3. *The name of the Institution may also be updated on the website of the NCTE in the list of recognised institutions and a letter be written to the Concerned Affiliating Body and the State Government.*

5. **AND WHEREAS**, a Restoration Order dated 17.06.2026 was issued and the institution was permitted to participate in the counselling for the academic session 2025-2026 and admit students for the said academic session.

6. **AND WHEREAS**, O/o the SRC received the proper order dated 17.06.2026 of the Hon'ble High Court of Delhi through the representation made by the petitioner institute via email, operative part of which is as under:

*"5. Accordingly, the present writ petition is allowed, holding that the directions passed by the Coordinate Bench in paragraphs Nos. 12 to 16 in the judgment of Teachers Training College Mirza (supra) shall apply to the petitioner, including the direction to permit the petitioner to participate in the counselling session for the academic session 2026-2027.*

*6. All respondents shall ensure that the petitioner is permitted to participate in the counselling for academic session 2026-2027."*

7. **AND WHEREAS**, the SRC in its 506<sup>th</sup> Meeting held on 24<sup>th</sup> June, 2026 considered the above Court directions and decided as under:-

*"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time were placed before the Committee and the SRC after careful consideration made the following observations: -*

- *The institution filed a W.P. No. 8241/2026 before the Hon'ble High Court of Delhi. and the Hon'ble Court passed order dated 17.06.2026. The operative part of the order is as under:*

*"5. Accordingly, the present writ petition is allowed, holding that the directions passed by the Coordinate Bench in paragraphs Nos. 12 to 16 in the judgment of Teachers Training College Mirza (supra) shall apply to the petitioner, including the direction to permit the petitioner to participate in the counselling session for the academic session 2026-2027.*

*6. All respondents shall ensure that the petitioner is permitted to participate in the counselling for academic session 2026-2027."*

**Keeping in view the above, the SRC decided as follows:**

*"In compliance of the directions passed by Hon'ble High Court of Delhi vide order dated 17.06.2026 in W.P. No. 8241/2026, a revised Restoration Order, in supersession of earlier restoration order dated 17.06.2026, be issued to the institution permitting the institution to participate in the counselling for the*

*Academic Session 2026-27 for D.El.Ed. programme with annual intake of 50 students (One Basic Unit). The same shall be communicated to the affiliating body and state authority as well."*

8. **NOW THEREFORE**, in view of the above, Revised Restoration order in supersession of earlier restoration order dated 17.06.2026 is hereby issued to **Nauman College of Elementary Teacher Education, Sy. No. 374, Steet No. 09, Kodad Village and Post, Nalgonda District – 508206, Telangana** permitting the institution to participate in the counselling for the Academic Session 2026-27 for D.El.Ed. programme with annual intake of **50 students (One Basic Unit)**. It is also communicated to the affiliating body and state authority as well.
