ORDER

WHEREAS, Abdul Kalam Educational Society, Habsipur Road, Dubbak Village and Post, Dubbak Taluka and Town, Medak-502108, Andhra Pradesh had submitted an application for seeking recognition to SR College of Teacher Education Muslim Minority Institution, Khasara No.117, H Road, Dubbak Village and Post, Medak-502108, Andhra Pradesh for B.Ed Course on 12.10.10.

AND WHEREAS, the Application was scrutinized and the inspection of the institution was conducted on 01.04.2011. The SRC considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve Show Cause Notice. As per direction of SRC Show Cause Notice was issued to the applicant institution on 27.05.2011.

AND WHEREAS, in response to this office Show Cause Notice dt. 27.05.2011 the institution submitted reply vide letter dated 24.06.2011, explaining and clarifying the points raised in the Show Cause Notice. The reply was placed before SRC in its 208th Meeting held on 13-14th of July 2011, the committee considered the reply and other relevant documents and decided to issue letter of intent prior to recognition. Accordingly, Letter of Intent was issued to applicant institution on 20.07.2011.

AND WHEREAS, in response to Letter of Intent dt. 20.07.2011 the institution s submitted reply vide letter dt. 02.08.2011. Reply to LOI was considered in 210th SRC Meeting held on 22nd- 23rd August 2011 and it was decided to serve notice. Accordingly Notice was issued on 28.10.2011. In response to this notice dt. 28.10.2011 the institution submitted reply vide letter dated 04.11.2011.

AND WHEREAS, Southern Regional Committee considered the reply to Notice submitted by the Institution in its 213th SRC meeting held on 24th October 2011. The committee decided to issue Formal Recognition.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to **SR College of Teacher Education Muslim Minority Institution, Khasara No.117, H Road, Dubbak Village and Post, Medak-502108, Andhra Pradesh** for conducting B.Ed Course duration of one year duration with intake of 100 Students from the academic session **2012-2013** under clause 7(11) of NCTE Regulations, 2009 subject, to fulfillment of the following conditions:

- The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.

- iv The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- v The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- vi The institution / Management shall produce valid minority certificate from the notified authority of the respective State Government for the subsequent years 2012-13 onwards.

Further Southern Regional Committee in its 208th Meeting held on 13th and 14th July 2011 also resolved that the institutions which have fulfilled all the requirements as per norms and regulations excepting the minority certificate be directed to submit a notarized statement/ undertaking

1. The Institution shall declare themselves as minority trust and minority institution proposed to be established, and give an undertaking that the management shall produce valid minority certificate from the notified authority of the respective State Government on or before 31st March 2012, failing which, the institution shall be de recognized automatically without any further notice and that such institutions shall make no further admission thereafter.
2. The said institution has submitted Minority certificate only for 2011-12 and for 2012 -2013 as such requisite undertaking may be submitted immediately.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

The institution shall submit to the Southern Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

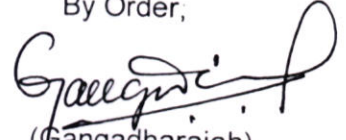
1. Copy of the Application Form
2. Land and Building Particulars
3. Staff Profile
4. Recognition letter
5. Information for having fulfilled the norms & standard and other required conditions.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
