**CONTINUATION ORDER**

WHEREAS, the institution namely **Cattamanchi Ramalinga Reddy College of Education, Dinnedevrapadu, Post Box no. 8, NH-7, Kurnool Mandal, Kurnool, Andhra Pradesh** run by **Cattamanchi Ramalinga Reddy Educational Society, Kurnool-2, Andhra Pradesh** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/2915 dated 16.05.2007 for conducting Secondary **B.Ed.** course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 19.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting **B.Ed. Programme of two years duration** with an annual intake of 100 for **two basic units** of 50 students each from the academic session 2015-16.

3. **AND WHEREAS**, a corrigendum order was issued to the institution vide order no. F.SRO/NCTE/APSO7036/B.Ed./AP/2015/77112 dt. 27.10.2015 for grants recognition to **Cattamanchi Ramalinga Reddy College of Education, Dinnedevrapadu, Post Box no. 8, NH-7, Kurnool Mandal, Kurnool, Andhra Pradesh-2** for conducting **B.Ed.** programme for two years duration with an annual intake of 50 students of **one basic unit** from academic session 2015-2016.

4. **AND WHEREAS** The SRC in its meeting held on 22<sup>nd</sup> October 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted and the Sub-Committee decided to issue Show Cause Notice. Accordingly, a First Show Cause Notice was issued to the institution on 24.10.2019. The institution vide letter dated 18.12.2019 submitted reply to the Show Cause Notice.

5. **AND WHEREAS**, the matter placed before the SRC in its 393<sup>rd</sup> meeting held on 05<sup>th</sup> & 06<sup>th</sup> January 2021 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 11.01.2021. The institution has submitted Final Show Cause Notice reply on 25.03.2021.

6. **AND WHEREAS**, the SRC in its 397<sup>th</sup> Meeting held on 25<sup>th</sup> & 26<sup>th</sup> March 2021 the matter was considered the matter and decided to issue last reminder letter to the institution. Accordingly, as per decision of SRC a last reminder letter. The institution has submitted reply of last reminder letter on 09.04.2021.

7. **AND WHEREAS**, the matter was considered by the SRC in its 399<sup>th</sup> Meeting held on 15<sup>th</sup> & 16<sup>th</sup> June 2021 decided as under: -

- a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left or joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
  13. The institution shall make available the list of students admitted on its official website.
  14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
