SHIFTING ORDER

WHEREAS, recognition u/s 14 NCTE Act, 1993 was granted to the institution namely Vijaya College of Education, Plot/Khasara No.898, Chilamakuru Village, Chirrajupalli Gramapanchayath & Post Office, Yerraguntla Mandal & Taluk, Chilamakur Town, Kadapa District-516310, Andhra Pradesh run by Moole Vijayalakshmi Educational Society, Plot No. 201, Street/Road: Ushasree Residency, Village: D. No: 23-11-269/201, S.V. Nagar, Tirupati Urban Mandal Post Office, and Taluk, Tirupati Town/City, Chittoor District, Andhra Pradesh-517502 vide SRC order No. F.SRCAPP14518/B.Ed./AP/2016/84887 on 02.05.2016 for conducting B.Ed. course of two-year duration with an annual intake of 50 students from the academic session 2016-2017.

2. **AND WHEREAS**, the SRC in its 408th meeting held on 02nd March 2022 taken the decision to issue a Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulation, 2014. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 26.04.2023. The institution has not submitted reply of the Show Cause Notice.

3. **AND WHEREAS**, the SRC in its 426th meeting held on 23rd June 2023 considered the matter and Committee decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 03.07.2023.

4. **AND WHEREAS**, the institution has submitted application for shifting of premises along with DD No. 932615 Rs. 150000/- & DD No.932660 Rs.270000/-. The SRC in its 428th Meeting held on 25th-August 2023 has considered the matter and decided to issue letter to the institution. Accordingly, as per the decision of SRC, a letter was issued to the institution on 31.08.2023.

5. **AND WHEREAS**, the institution has submitted a written representation to the letter along with requisite documents on 19.09.2023. The SRC in its 429th Meeting held on 11th October, 2023 has considered the matter and decided to constitute the online VT for shifting premises. The inspection was conduct on 28.12.2023 and VT report received on 28.12.2023.

6. **AND WHEREAS**, the SRC in its 431st Meeting held on 10th January, 2024 considered the VT Report and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued on 29.01.2024. The institution has submitted its reply on 27.02.2024.

7. **AND WHEREAS**, the SRC in its 434th meeting held on 22nd March, 2024 considered the matter and decided as under:-
