CONTINUATION ORDER**

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely **Sri Gokulakrishna College of Education, Aattakarampatti, pennagaram Main Road, Dharamapuri-636809, TamilNadu** run by **Venkateshwara Educational Trust, 33/45-SI, Manavasi Narashiman Road, Gandhi Nagar, Dharmapuri-636701, TamilNadu** vide order No.F.SRO/NCTE/B.Ed./2008/5042 dated 22.09.2008 for conducting **B.Ed. Course** of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 25.02.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 23.03.2015 for conducting **B.Ed. Programme** of two years duration with an annual intake of 50 students (One Unit) from the academic session 2015-16.
3. **AND WHEREAS**, the SRC in its 368th Meeting held on 08th & 09th January 2019 the matter was considered and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 19.02.2019. The institution has submitted its reply on 08.02.2019.
4. **AND WHEREAS**, the SRC in its 374th Meeting held on 09th & 10th April 2019 the matter was placed before the Committee and decided to issue Withdraw order. Accordingly, as per decision of SRC vide order no. F.SRC/NCTE/APS09377/104254-4259 dt. 07.05.2019 a withdrawal order was issued to the institution.
5. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. no.89-265/E-123813/2019 Appeal/38th Meeting 2019/28th November 2019/86581 dt. 23.12.2019 appeal remand back the order appealed against.
6. **AND WHEREAS**, the SRC in its 383rd Meeting held on 07th & 09th January 2020 the matter was placed before the Committee and considered the matter and decided to issue Final Show Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 21.01.2020. The institution did not submit any reply to Final Show Cause Notice.

7. **AND WHEREAS**, the SRC in its 384th Meeting held on 12th & 13th February 2020 the matter was considered before the Committee and decided to issue another Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 10.08.2020. The institution has submitted a reply to the institution on 22.09.2023.

8. **AND WHEREAS**, the SRC in its 429th meeting held on 11th October 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Sri Gokulakrishna College of Education, Survey No. 12/2, Aattakarampatti Pappinaickanahalli Village, Pennagaram Main Road, Dharmapuri, Tamilnadu-636809 for B.Ed. programme for 1 basic unit of 50 students".

9. **NOW THEREFORE**, this order is issued permitting the institution i.e. Sri Gokulakrishna College of Education, Survey No. 12/2, Aattakarampatti Pappinaickanahalli Village, Pennagaram Main Road, Dharmapuri, Tamilnadu-636809 run by Venkateshwara Educational Trust, 33/45-SI, Manavasi Narashiman Road, Gandhi Nagar, Dharmapuri-636701, TamilNadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.


If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the

Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
