ORDER

WHEREAS, Jawaharlal Nehru Education Society, Vemulawada-505 302, Karimnagar District, Andhra Pradesh had applied for grant of recognition to Jawaharlal Nehru Elementary Education Training Institute, Market Road, Vemulawada-505 302, Karimnagar District, Andhra Pradesh for Elementary (D.Ed) course of two years duration from the academic session 2005-06 with an annual intake of 50 students. Accordingly, recognition order was issued to the institution on 26.08.2005 with a condition to shift to its own premises within 3 years from the date of recognition.

AND WHEREAS, On 26.05.2014 a copy of the proceedings of the Director, SCERT, Andhra Pradesh, Hyderabad dated 13.05.2014 addressed to the correspondent, Jawaharlal Nehru Elementary Education Training Institute seeking explanation regarding offering of D.EL.Ed course for the year 2013-14, in lack of complete faculty is received by this office which is as under:-

.... the attention of the correspondent, Jawaharlal Nehru Elementary Teacher Education College, Mallaram Road, Vemulawada, Karimnagar District – 505302 is invited to the reference 5th read above, in it the correspondent concerned was requested to furnish the copies of recognition order of the NCTE, Renewal of affiliation accorded by the DSE and latest staff approval order. But, till date the correspondent concerned has not responded to this office order. It seems that the said institution is imparting the D.Ed course, in lack of complete faculty since the academic year 2011-12. The action of the college concerned is against the NCTE Norms, 2009, terms and conditions prescribed by the Regional Director, NCTE, SRC, Bangalore in their recognition orders and state education policy.

Hence, the correspondent, Jawaharlal Nehru Elementary Teacher Education College, Mallaram Road, Vemulawada, Karimnagar District – 505302 is directed to explain the reasons as to why the matter should not be brought to the notice of the National Council of Teachers Education, SRC, Bangalore, for de-recognition of the institution and de-affiliating the college hence forth by the department. Further the correspondent concerned is also directed to furnish the administrative and financial audit reports of the institution for the years 2011-12 and 2012-13 along with necessary proofs of payment of salaries to the faculty of the institution since 2011-12 to till date.

The explanation should be reached to this office within one week from the date of receipt of this order. Otherwise, it will be construed that there is no defense from the end of the college concerned and strait away further action will be taken".

AND WHEREAS, the Southern Regional Committee in its 268th meeting held during 4th & 5th June, 2014 considered the matter, proceedings of the Director, SCERT, Andhra Pradesh, Hyderabad dated 13.05.2014, and all the relevant documentary evidences of the institution and it was decided to serve Show Cause Notice Under NCTE Act.

AND WHEREAS, as per the decision of SRC, a show cause notice was issued to the institution on 07.08.2014. The institution has submitted a written representation on 01.09.2014.

AND WHEREAS, as per the decision of 273rd meeting held during 30th September & 1st October, 2014, a show cause notice was issued to the institution. The institution has replied vide their letter dated 01.09.2014. The Committee considered the matter, noted and decided that:

"The Show Cause Notice issued was not specific. Advised Southern Regional Office to Re-issue with reference to the following 3 points:

- (i).Adherence to the staffing pattern as given in 2009 Regulations.
- (ii).Failure to shift premises within 3 years of recognition.
- (iii).Availability of a valid affiliation."

AND WHEREAS, accordingly, the institution has submitted the written representation on 10.02.2015 as under:-

- "1. We have not submitted new proposals for SCERT staff approval lists from 2011-12, because there is no-change in approved staff by SCERT, Hyderabad, from 2011-12 to 2014.
- 1. We have started College Building Construction in 2011 and completed full pledged building in 2013 and shifted the building in January 2014. We have also intimated these to the NCTE Bangalore vide letter No,3/2014 dt. 09.01.2014. Please intimate us to shifting premission fee details. We will pay the amount within one week.
- 2. Some changes of teaching faculty in 2014-15 as per NCTE rules & regulations to select the new faculty instead of vacancies through staff selection committee, under the supervision, principal, GOVERNMENT DIET COLLEGE, Karimnagar. Interviews conducted and selected candidates list submitted SCERT, Hyderabad. They are also approved selection committee list. List also submitting herewith.
- 3. Now we have full plazed faculty as per NCTE rules and regulation. Submitting here with the SCERT, Hyderabad Approved list RC No.893 SCERT-AP/AITE/TSCERT 2012 date 20.01.2015.
- 4. We are submitting SCERT, Hyderabad affiliation letter for 2014-15 year. Letter No:172/NI-3/SCERT/14-16/dated:20.10.2014.
- 5. We are submitting - with this No-Objection Certificate issued by the fire service department, Karimnagar.

The institution has submitted its written representation on 10.02.2015.

AND WHEREAS, the Southern Regional Committee in its 285th meeting held during 17th April, 2015 considered the written representation of the institution dated 10.02.2015 and decided as under:

- 1. This is a shifting case.
- 2. Cause inspection.

AND WHEREAS, as per the decision of SRC, the inspection of the institution was fixed between 23rd -25th April, 2015. The same was intimated to the institution on 20.04.2015. accordingly, the inspection of the institution was conducted on 24.04.2015. The VT Report was received by this office on 27.04.2015.

AND WHEREAS, the Southern Regional Committee in its 286th meeting held on 30th April 2015, considered the visiting team report, VCD, relevant documents and it was decided to permit Shifting of premises for D.Ed.

NOW THEREFORE, permission is hereby accorded by SRC to **Jawaharlal Nehru Elementary Education Training Institute, Market Road, Vemulawada-505302, Karimnagar District, Andhra Pradesh** to shift its premises to the new location / building at **Jawaharlal Nehru Elementary Education Training Institute, Vemulawada-505302, Karimnagar District, Andhra Pradesh**

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
