CONTINUATION ORDER

WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sa-Ya Gosh College of Education, K. N. HalliVilalge, Bysuhalli Post, Dharmapuri District – 636205, Tamil Nadu run by Sa-Ya Gosh Educational Trust, Periyanaahalli, Dharmapuri District – 635205, Tamil Nadu vide order No. F.TN/SEC/SRO/NCTE/2006-07/6915 dated 26.07.2006 for conducting Secondary B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2005-06.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 19.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 05.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 31.01.2019. The institution has not submitted any reply in respect of Show Cause Notice.

4. AND WHEREAS, the institution along with regulatory file was placed before the SRC in its 384th meeting held on 12th – 13th February 2020 and the Committee decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued on 10.08.2020. the institution has not submitted reply of FSCN.

5. AND WHEREAS, the SRC in its 395th meeting held on 25th – 26th February 2021 has considered the matter and decided to withdraw the Recognition. Accordingly, as per the decision of SRC, a withdrawal order No.F.SRC/NCTE/APSO4318/B.Ed./TN/2021/125193-125200 was issued to the institution on 16.03.2021.

6. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-151/E-256912/2022 Appeal/5th Meeting, 2022 No.APPLSRC202214241 dated 12.07.2022 and order No.89-150/E-2516912/2022 Appeal/5th Meeting, 2022 APPLSRC202214242 Appeal Committee of the council concluded that the SRC was justified in withdrawing recognition and therefore the instant appeal deserved to be rejected and the impugned withdrawal order is confirmed.

7. AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No.13842/2022 & CM APPLs. 42330-42331/2022 titled as Sa-Ya Gosh College

of Education versus National Council for Teacher Education & Anr. Whereby the Hon'ble High Court has directed that: -

"Respondents are directed to update the status of Petitioner, within a period of one week from today, and send an intimation in respect thereof to the affiliating university of Petitioner as well as to the concerned Department of Education to enable them to participate in counselling and admission process for academic session 2022-23."

8. **AND WHEREAS**, in compliance of court order dated 26.09.2022, the office of SRC has issue an order vide order No.SRO/NCTE/APSO4318 /B.Ed./AP/2022 /136418 dated 19.10.2022 to the institution.

9. **AND WHEREAS**, in compliance of court order dated 26.09.2022, the Appellate Authority vide order No. 89-151/E-256912/2022 Appeal/7th Meeting, 2023 APPLSRC202114241 dated 13.07.2023, the Council remands back the case. The institution has submitted reply as per direction of appeal authority order dated 14.07.2023.

10. **AND WHEREAS**, the SRC in its 427th meeting held on 20th July 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Sa-Ya Gosh College of Education, Survey No. 218, 219, 220/2 and 221/1, Boomanadhahalli, Boomanadhahalli Panchayat, Karimangalam Union, Dharmapuri District – 636205, Tamil Nadu for B.Ed. programme for 2 basic units of 50 students each."***

11. **NOW THEREFORE**, this order is issued permitting the institution i.e. Sa-Ya Gosh College of Education, Survey No. 218, 219, 220/2 and 221/1, Boomanadhahalli, Boomanadhahalli Panchayat, Karimangalam Union, Dharmapuri District – 636205, Tamil Nadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

13. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

16. The institution shall make available the list of students admitted on its official website.

17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.




