ORDER

WHEREAS the appeal of Pasha College of Education, Neredmet, Telangana, Hyderabad dated 25/12/2019 is against the Show Cause Notice dated 11/10/2019 of the Southern Regional Committee, proposing to withdraw recognition for conducting for B.Ed. Course on the grounds that "The institution was issued Final Show Cause Notice on 11.10.2019. But the institution has not yet submitted its reply till date. Hence, the Committee decided to withdraw the recognitions granted to Pasha Educational Training Institute, 8-2-672, Road No.13, Banjara Hills, Hyderabad-500035, Telangana for conducting B.Ed. courses w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

AND WHEREAS Dr. V. Bala, Principal, Pasha College of Education, Neredmet, Telangana, Hyderabad presented the case of the appellant institution on 25/02/2020. In the appeal and during personal presentation it was submitted that "Institution did not receive the alleged show cause notices dt. 31.05.18 & 11.10.19. Institution was granted permission to shift the premises by the NCTE vide order/corrigendum dt. 11.08.2015. All the alleged communications as apparent from the minutes of meeting no. 382nd meeting & final show cause, are being sent to the earlier address, which does not belong to the institution. The SRC has failed to update their record. Furthermore, it is pertinent to mention that the institution was served by the final show cause on its email id on 14.11.2019 and the institution duly replied to the same vide e-mail as well as speed-post on 16.11.2019 & 18.11.2019 respectively. The SRC has failed to take notice of the same and has issued withdrawal order without any basis. It is pertinent to mention that the institution duly complied with the final show cause notice as received on mail and submitted all the documents as asked for vide reply dt. 28.11.2019. Further the

institution has vide email letter dt. 30.11.2019 also made a representation before SRC detailing everything.”

AND WHEREAS Appeal Committee noted that appellant institution had neither enclosed copy of the impugned order issued under Section 17 of the NCTE nor enclosed minutes of SRC wherein it has been decided to withdraw recognition. By issue of Show Cause Notice (SCN), SRC has just given opportunity to appellant institution to submit its written representation and appellant states that it had furnished required documents to SRC on 27/11/2019.

AND WHEREAS Appeal Committee decided that until SRC decides to withdraw recognition and issues order under Section 17 of the NCTE Act, there is no case for an appellant to prefer appeal under Section 18 of the Act. Present appeal is therefore, dismissed as not acceptable.

ORDER

WHEREAS the appeal of Yuva Vyavsaik Shikshan Mahavidyalaya, Bypass Road, Guna, Madhya Pradesh dated 31/12/2019 is against the Order No. WRC/APW06537/225117/288th /2018/196275, 276, 277, 278, 279, 280, 281, 282 dated 13.03.2018 of the Western Regional Committee, withdrawing recognition for conducting for M.Ed. Course on the grounds that "and whereas, the reply of compliance letter not received, the matter was placed before the WRC in its 288th meeting held on February 15-16, 2018. The Committee decided that "...The institution vide letter dated 25.09.2014 has requested for closure of M.Ed. course. Compliance letter for submission of resolution of society was issued on 22.12.2014. Reply has not been received till date. Hence, Recognition is withdrawn from the academic session 2018-2019."

AND WHEREAS Sh. Vijay Sisarwal, Admin. Officer, Yuva Vyavsaik Shikshan Mahavidyalaya, Bypass Road, Guna, Madhya Pradesh presented the case of the appellant institution on 25/02/2020. In the appeal and during personal presentation it was submitted that "Fake application was submitted by unknown person for closure of courses of NCTE like M.P.Ed., M.Ed. whereas institute has contacted NCTE, Bhopal wide Letter No. YUVA/466/18 on dated 19/02/2018 and also communicated with local police station YUVA/466/18 on dated 09/03/2018 against fake application of closure filed on behalf of the institution. The institute even did not think to close the institute."

AND WHEREAS Appeal Committee noted that Hon'ble High Court of Delhi at New Delhi by its order dated 06/02/2019 in W.P. (C) case no. 1273/2019 dismissed the petition as withdrawn with liberty to petitioner to avail the remedy of appeal. Appeal Committee noted that appellant institution preferred online appeal on 31/12/2019 i.e. after more than 10 months of the order of Hon'ble Court. The impugned order issued

on 13/03/2018 mentioned that appellant institution if not satisfied with the order, may prefer appeal to NCTE, New Delhi without 60 days. Appeal Committee noted that appellant institution had not only failed to timely submit online line appeal from the date of issue of impugned order i.e. 13/03/2018 but also could not submit online appeal within 60 days from the date of order of Hon'ble Delhi High Court. Appellant in its appeal memoranda has stated the reason for delay as 'File FIR against unknown person and Court case.' Appellant did not submit copy of any FIR or the investigation report of the police.

AND WHEREAS Appeal Committee further noted that WRC by its letter dated 22/12/2014 had apprised the Principal of the institution the decision of the Sansthan to close the institution on grounds of not getting students. There was no reply from the appellant institution till the impugned order of withdrawal was issued.

AND WHEREAS Appeal Committee also noticed that WRC had taken considerable long time and the delay between issue of SCN dated 22/12/2014 and issue of impugned order dated 13/03/2018 is not justifiable.

AND WHEREAS Appeal Committee, therefore, is of the opinion that WRC before making a final decision after a prolonged period of 4 years should have considered and examined the following points:-

- (a) Number of candidates admitted in M.Ed. course and degrees awarded year wise after 2014-15.
- (b) Affiliation granted or not by the affiliating university after 2014-15 year wise.
- (c) Whether appellant institution had appointed faculty with the approval of affiliating body and evidence of salary paid to them year wise after 2014-15.

AND WHEREAS Appeal Committee decided to remand back the case to WRC for revisiting the matter. Appellant institution is also required to submit to WRC within 15

days of the issue of appeal order, (i) List of students admitted and awarded degrees of M.Ed. course since 2014-15, (ii) affiliation letters of the university pertaining to M.Ed. course, (iii) Bank Statement in support of salary having been remitted into the bank accounts of faculty since 2014-15.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter. Appellant institution is also required to submit to WRC within 15 days of the issue of appeal order, (i) List of students admitted and awarded degrees of M.Ed. course since 2014-15, (ii) affiliation letters of the university pertaining to M.Ed. course, (iii) Bank Statement in support of salary having been remitted into the bank accounts of faculty since 2014-15.

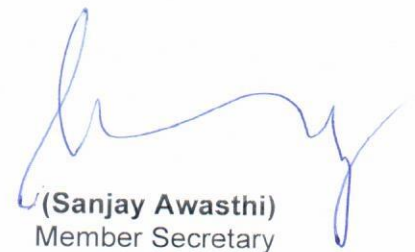

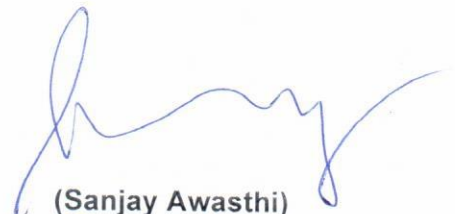

ORDER

WHEREAS the appeal of Shri Rawatpura Sarkar College of Education, Village—Chitrakoot, Majhgawa, Satna, Madhya Pradesh dated 14/10/2019 is against the Order No. WRC/APW04903/223545/B.Ed./310th/2019/206009 dated 05.09.2019 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that “the Show Cause Notice was issued to the institution vide letter dated 26/05/2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice. Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.”

AND WHEREAS F/L (Ex) Amita Saxena, Director, Shri Rawatpura Sarkar College of Education, Village—Chitrakoot, Majhgawa, Satna, Madhya Pradesh presented the case of the appellant institution on 25/02/2020. In the appeal and during personal presentation it was submitted that “Shri Rawatpura Sarkar College of Education, Chitrakoot, has not received any show cause notice dated 25 May 2017. Therefore, the Institute reply did not reach NCTE office. This is also brought out that we had submitted all documents pertaining to staff land as mentioned in NCTE WRC withdrawal 09 Aug 2019 earlier vide SSCE/16-17/20 Dated-26/11/2016. Our College Infrastructure, staff is complete and as per Norms and attached herewith for your kind reference. We are Accredited by NAAC also. It is most humbly prayed that it is not our fault and we could not reply to SCN as we could not received letter in our office. Our College is functioning.”

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 05/09/2019 is on the ground that appellant institution has not replied to Show

Cause Notice dated 26/05/2017. Appeal Committee further noted that appellant institution was asked to furnish (a) original staff profile for the session 2015-16 duly approved by affiliating body (b) originally notarised CLU, NEC, Building Plan and B.C.C. From the regulatory file it is observed that appellant institution by its letter dated 21/07/2018 had furnished revised FDRs to WRC and in its letter had not mentioned of any S.C.N. dated 26/05/2017. Appellant during the course of appeal hearing stated that S.C.N. dt. 26/05/2017 was not received and hence no reply could be given. Appeal Committee noted that after getting the FDRs, WRC also did not remind the appellant institution that some more information as required in the S.C.N. has still not been received.

AND WHEREAS appellant during the course of appeal hearing submitted copy of (i) faculty approval letter dated 27/12/2019 issued by Awdesh Partap Singh University, Rewa, (ii) List of faculty approved by Registrar of affiliating university, (iii) Land documents, (iv) NEC (v) CLU, (vi) Building Plan and (vii) Building Completion Certificate.

AND WHEREAS Appeal Committee decided that appellant institution is required to submit to WRC within 15 days of the issue of appeal order authenticated / originals of the required document and shall also submit evidence to prove that required number of faculty as per NCTE Regulations, 2014 was in position since 2015-16. Appeal Committee further decided to remand back the case to WRC for revisiting the matter after the appellant institution submits the required documents.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee decided that appellant institution is required to submit to WRC within 15 days of the issue of appeal order authenticated / originals of the required document and shall also submit evidence to prove that required number of faculty as per NCTE Regulations, 2014 was in position since 2015-16. Appeal Committee further decided to remand back the case to WRC for revisiting the matter after the appellant institution submits the required documents.

NOW THEREFORE, the Council hereby remands back the case of Shri Rawatpura Sarkar College of Education, Village–Chitrakoot, Majhgawa, Satna, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Prof. Qoumrul Hoque School of Education University of Science and Technology, Baridua, Kling Centre, Ri-Bhoi, Meghalaya dated 23/08/2019 is against the Order No. ER-274.14.83/(ERCAPP-45/2012)/B.Ed./2019/61151 dated 05.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "the reply of SCN was not received within stipulated time."

AND WHEREAS Dr. S.A. Moin, Member and Dr. Nurujjaman Laskar, Representative, Prof. Qoumrul Hoque School of Education University of Science and Technology, Baridua, Kling Centre, Ri-Bhoi, Meghalaya presented the case of the appellant institution on 25/02/2020. In the appeal and during personal presentation it was submitted that "Officer who received the show cause notice did not hand over the same to the concerned authority and had subsequently taken leave. As a result the letter was traced late."

AND WHEREAS Appeal Committee noted that a combined Show Cause Notice (SCN) dated 18/05/2019 was issued to 71 institutes for submitting compliance regarding enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintaining website as per revised recognition order. Impugned order of withdrawal dated 05/08/2019 is on the ground that appellant institution did not submit reply to S.C.N. dated 18/05/2019.

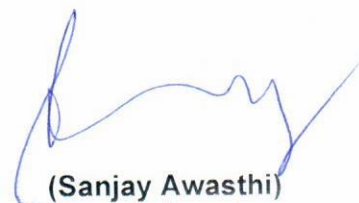

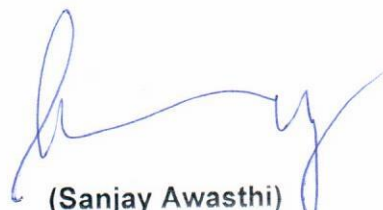
WHEREAS the appeal of District Institute of Education & Training (DIET), Village – Chiri, Kuru, Loherdaga, Jharkhand dated 23/12/2019 is against the Order No. ERC/215.9(i).e/ERCAPP1526/D.El.Ed./2015/47948 dated 12.07.2016 of the Eastern Regional Committee, refusing recognition for conducting for D.El.Ed. Course on the grounds that “letter of intent u/c 7(13) to the institution was issued on 10.02.2014. A clarification letter to the institution was issued on 01.03.2015. No reply received. Show Cause Notice was issued on 17.11.2015. No reply from the institution has been received till date and time limit is over. WHEREAS the appeal of Vidhyasagar College, Village – Bicholi Mardana, Indore, Madhya Pradesh dated 07/12/2019 is against the Order No. WRC/APW05017/224143/311th /{M.P.}/2019/206501 - 206508 dated 09.10.2019 of the Western Regional Committee, withdrawing recognition for conducting for B.P.Ed. Course on the grounds that “the revised recognition order was issued to the institution vide order dated 16/05/2015. The SCN was issued to the institution on 01/02/2017. The institution has submitted reply of SCN on 04/04/2017. The summary of the case reveals that the re I was not submitted within the stipulated time of 30 days as per the Show Cause Notice. Moreover, the reply of the institution the committee observed that: The institution has submitted staff profile one HOD and Seven Assistant professor signed by Registrar, Devi Ahilya University, Indore which is not as per NCTE Regulations. The institution has not submitted letter of granting approval from affiliating University in original. The institution has not submitted NEC issued by the competent authority. The institution has not submitted land Use certificate issued by the competent authority. The institution has not submitted copy of building plan mentioning khasra/Plot No., total land area, total built up area and earmarked area for each course being run in the same premises. Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.P.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.”

AND WHEREAS Dr. Nilesh Kumar Patel, Principal, Vidhyasagar College, Village – Bicholi Mardana, Indore, Madhya Pradesh presented the case of the appellant institution on 25/02/2020. In the appeal and during personal presentation it was submitted that the procedure of appointment of the staff was under the process by the university and department of higher education at that time. Therefore, the existing staff

list was submitted. Now the staff list is updated as per latest NCTE Regulations and is approved by Affiliating University is available. The university delayed the approval every year. That is why the approval could not be submitted. Now the university issued the approval letter. So, it is available. The college has applied for shifting of premises and land related documents including NEC, CLU and building plan was submitted with the application of shifting of premises."

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 09/10/2019 is on the ground that the list of faculty submitted by appellant institution contained inadequate staff, the staff profile was of one H.O.D., seven Assistant Professors and the institution has not submitted NEC, CLU and Building plan etc.

AND WHEREAS appellant institution during the course of appeal hearing on 25/02/2020 submitted before Appeal Committee:-

- (a) Copy of letter dated 07/12/2019 of affiliating university granting approved to H.O.D. and required number of faculty.
- (b) List of faculty approved by Registrar, Devi Ahilya University, Indore.
- (c) Affiliation letters
- (d) CLU
- (e) NEC
- (f) Building Plan and B.C.C.

AND WHEREAS Appeal Committee noted that appellant institution is conducting B.P.Ed. course since 2008. Appellant institution is required to submit to WRC within 15 days of the issue of Appeal order originals and authenticated copies of the documents required as per Show Cause Notice. Appeal Committee further decided to remand back the case to WRC for revisiting the matter after receiving the required documents from the appellant institution.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter after receiving the required documents from the appellant institution.

Appeal Committee decided to remand back the case to ERC for revisiting the matter after the appellant submits required documents.

WHEREAS the appeal of Siddharth Mahavidhyalay, Jaswant Nagar, Ludhpura, Etawah, Uttar Pradesh dated 08/01/2020 is against the Order No. NRC/NCTE/NRCAPP-5140/304th Meeting/2019/206105-110 dated 25.09.2019 of the Northern Regional Committee, refusing recognition for conducting for B.Ed. Course on the grounds that "the institution's communication to the NRC dated 09.07.2018 was placed before the Committee, in which the Hon'ble High Court's order was enclosed by the applicant. The Hon'ble High Court had dismissed the petition to apply afresh in accordance with law. In the light of the judgement, the NRC decided that the applicant that the applicant may make a fresh application in prescribed format which shall be considered in accordance with Act and Regulations, 2014."

AND WHEREAS Sh. Moh. Irfan Khan, Clerk, Siddharth Mahavidhyalay, Jaswant Nagar, Ludhpura, Etawah, Uttar Pradesh presented the case of the appellant institution on 25/02/2020. In the appeal and during personal presentation it was submitted that by means of the present Writ Petition the Petitioner has challenged the order date 25/09/2019 passed by Regional Director, National Council for Teacher Education, New Delhi whereby the application for grant of B.Ed. course two-year durations date 28/12/2012 has been rejected. Shree Dhananaj Avasthi, learned counsel for the respondent submit that against the rejection of recognition application appeal is provided under section 18 of the National Council for Teacher Education Act, 1993 here in after referred to as the Act.

AND WHEREAS Appeal Committee noted that appellant institution submitted online application dated 28/12/2012 seeking recognition for conducting B.Ed. course. Appeal Committee noted that after processing the application, NRC issued a letter dated

18/12/2013 to Visiting Team Members with a proposal to inspect the appellant institution to assess its preparedness for conducting the course. Appeal Committee further noted that appellant institution by its letter dated 29/12/2013 addressed to Regional Director, NRC informed that due to lack of sufficient resources with the appellant institution it is not possible to get the institute inspected shortly and inspection shall be postponed till the institution supplements its resources. Appeal Committee noted that a Show Cause Notice (SCN) dated 24/04/2015 was issued to appellant institution on the ground that V.T. visited the institution on 02/01/2014 and found that nobody was there to get the institution inspected. Appeal Committee noted that thereafter NRC issued a refusal order dated 10/08/2015 but this refusal order referred to some other SCN dated 28/01/2014.

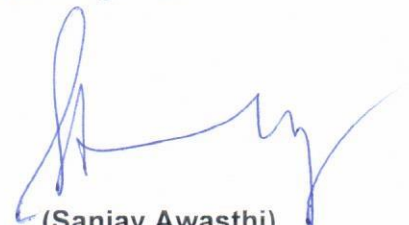
AND WHEREAS Appeal Committee, on perusal of the regulatory file noted that appellant had filed a Writ (C) No. 22973 of 2018 and the Hon'ble Court by its order dated 09/07/2018 dismissed the petition as withdrawn with liberty to the petitioner to apply afresh in accordance with law. NCTE Regulations stipulates that "At the time of inspection, the building of the institution shall be complete in the form of permanent structure, equipped with all necessary amenities and fulfilling such requirements as prescribed in the Norms and Standards." Appeal Committee further noted that inspection of the applicant institutes is not subject to the consent of applicant institution.

AND WHEREAS Appeal Committee noted that appellant institution instead of applying afresh as per orders dated 09/07/2018 of Hon'ble High Court resubmitted on 16/07/2018 its earlier application dated 28/12/2012. NRC by its letter dated 19/09/2018 informed the applicant institution to make a fresh application in prescribed format in accordance with NCTE Regulation, 2014. Subsequently another Show Cause Notice dated 14/01/2019 was issued on the grounds of non submission of (i) NOC of affiliating body (ii) evidence of being a composite institution as per Clause 2 (b) of NCTE Regulation, 2014. Appellant by its letters dated 11/02/2019 and 18/03/2019 submitted to NRC the required documents.

AND WHEREAS Appeal Committee noted that after considering per NCTE Regulation, 2014 can be filed online only as and when applications are invited by NCTE and the NCTE portal is made functional to accept applications. Appeal Committee is aware that NCTE has not issued any notification inviting applications for B.Ed. course after the year 2016. As such there was no opportunity for the appellant institution to have filed a fresh application as per NCTE Regulation, 2014. The order dated 09/07/2018 of the Hon'ble High Court of Allahabad in W.P. (C) No. 22973 of 2018 gives liberty to the petitioner to apply afresh in accordance with law. Petitioner / Appellant institution, as per above order of the Hon'ble High Court is entitled to apply afresh as and when NCTE issues notifications inviting fresh applications for the course. Appeal Committee, considering the circumstances of the case, decided to confirm the impugned order dated 25/09/2019 issued by NRC.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the impugned order dated 25/09/2019 issued by NRC.

NOW THEREFORE, the Council hereby confirms the Order appealed against.
