ORDER

WHEREAS, Lakhimpur Post Graduate Training College, North Lakhimpur, Lakhimpur, Assam-787001 was granted recognition for B.Ed. Course with an annual intake of 60 students from the academic session 1997-1998 vide ERC (NCTE) Order No.2802 dated 12.02.1997 followed by Order No.1842 dated 19/20.06.2002 from the academic session 2002-2003.

2. AND WHEREAS, revised recognition order issued vide No.32563 dt. 31.05.2015 for B.Ed. course of two year durations with an annual intake of 50 (One Basic Unit) from the academic session 2015-2016 as per NCTE Regulations, 2014.

3. AND WHEREAS, the ERC in its 283rd meeting held on 24th-25th August, 2020 decided that recognition granted to B.Ed. course be withdrawn from the academic session 2021-2022. Accordingly withdrawal order issued vide No.63002 dt. 09.09.2020.

4. AND WHEREAS, institution preferred appeal against the withdrawal order at NCTE HQrs. and the Appellate Authority vide order No.89-254/E-170204/2020 Appeal/31st Mtg.-2020/4th December, 2020/95923 dated 24.12.2020 remanded back the case to ERC for revisiting the matter.

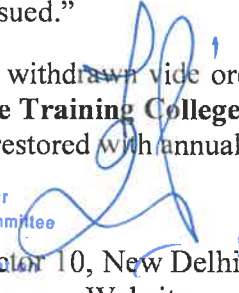

AND WHEREAS, the ERC in its 288th meeting held on 29th January, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 24.12.2020 and as decided, show cause notice was issued on 05.02.2021.

6. AND WHEREAS, the ERC in its 290th meeting held on 03rd March, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, and as decided show cause notice dated 19.03.2021 was issued to the institution.

7. AND WHEREAS, the ERC in its 300th ERC (Virtual) meeting held on 28th December, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, representations from the institution in response to show cause notice were carefully considered by ERC and the Committee decided as under:-

“Restoration of recognition order to the institution viz. Lakhimpur Post Graduate Training College, North Lakhimpur, Lakhimpur, Assam-787001 for B.Ed. course with annual intake of 50 students (01 unit) be issued.”

8. NOW THEREFORE, recognition withdrawn vide order dated 09.09.2020 issued to the institution viz. Lakhimpur Post Graduate Training College, North Lakhimpur, Lakhimpur, Assam-787001 for B.Ed. course is hereby restored with annual intake of 50 students (01 unit).

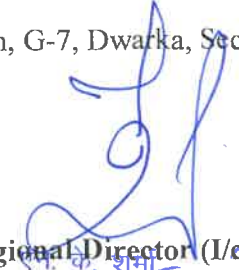
