ORDER

WHEREAS, Parjanya B.Ed. College, Plot No. 1, 3, 4, 5, 6, Street Number-Hirak Road, Vill.- Paharpur, P.O.- Baliapur, Tehsil/Taluka- Baliapur, City- Dhanbad, Dist.-Dhanbad, Jharkhand – 828201 (ERCAPP1124) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC dated 02.03.2013, followed by revised recognition order issued on 23.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS**, the ERC in its 275th meeting held on 27th July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61399 dated 26.08.2019 from the academic session 2020-2021 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 26.08.2019. The Appellate Authority vide order No.89-367/E-135953/2019 Appeal/33rd Mtg.-2019/21st November, 2019/85846 dated 05/12/2019 remanded to the ERC with a direction to consider the documents to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the documents submitted in appeal with originals thereof, wherever necessary within 15 days of receipt of orders on the appeal.
- 4. **AND WHEREAS**, the ERC in its 279th meeting held on 14th 16th February, 2020 after considering the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 05.12.2019 as well as reply dated 06.01.2020 submitted by the institution and the following observation was made:

"Restoration of recognition order of B.Ed. course to be issued".

5. NOW, THEREFORE, recognition withdrawn vide order dated 26.08.2019 to the institution viz. Parjanya B.Ed. College, Plot No. 1, 3, 4, 5, 6, Street Number- Hirak Road, Vill.- Paharpur, P.O.- Baliapur, Tehsil/Taluka- Baliapur, City-Dhanbad, Dist. Dhanbad, Jharkhand — 828201 (Code No. ERCAPP1124) for B.Ed. course is hereby restored.
