#### **ORDER**

WHEREAS, Patel B.Ed. College, Plot No. 49, Vill- Katamkuku, Po- Lodhma, Tehsil/Taluka-Karra, Town/City- Khunti, Dist.- Ranchi, Jharkhand- 834004 (Code No. ERCAPP705) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No. 13904 dated 31.08.2012, followed by revised order vide No.31758 dated 20.05.2015 an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHERAS,** the ERC in its  $274^{th}$  meeting held on  $15^{th} 16^{th}$  July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61162 dated 05.08.2019 from the academic session 2020-2021 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-13/E-147832/2020 Appeal/7<sup>th</sup> Mtg.-2020/25<sup>th</sup> February,2020/90429 dated 19/03/2020 remanded back the case to ERC for revisiting the matter after the appellant submits required documents.
- 6. **AND WHEREAS**, the institution submitted reply dated 27.03.2020 received in this office 08.05.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 02.03.2020, were carefully considered by ERC in its 282<sup>nd</sup> meeting held on 8<sup>th</sup> & 9<sup>th</sup> July, 2020 and the committee decided as under:-

"Restoration of Recognition Order of B.Ed. course to be issued".

7. NOW, THEREFORE, recognition withdrawn vide order dated 05.08.2019, Patel B.Ed. College, Plot No. 49, Vill- Katamkuku, Po- Lodhma, Tehsil/Taluka-Karra, Town/City-Khunti, Dist.- Ranchi, Jharkhand- 834004 (Code No. ERCAPP705) for B.Ed. course is hereby restored.
