ORDER

WHEREAS, Dr. Anita Baruah Sarma College of Education, Guwahati, Assam – 781024 (Code NoAPE00326) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2005-2006 vide ERC Order No. 2362 dated 20.07.2005, followed by revised order vide No.31841 dated 22.05.2015 an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its 272nd meeting held on 30th, 31st May & 1st June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60726 dated 14.06.2019 from the academic session 2020-2021 to the institution.

3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-278/E-125588/2019 Appeal/26th Mtg.-2019/26th August, 2019/82258 dated 26.09.2019 remanded back the case to ERC with a direction to consider the documents to be submitted to them and take further action as per the CNTE Regulations, 2014. The appellant is directed to forward to the ERC all the documents submitted in appeal within 15 days of receipt of orders on the appeal.

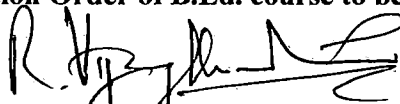
4. AND WHEREAS, the institution has submitted representation dated 24.10.2019 received in this office on 29.10.2019. The ERC in its 277th meeting held on 19th – 20th Dec, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution.

5. AND WHEREAS, the institution has submitted reply vide letter dated 09.01.2020 received in this office on 13.01.2020. The ERC in its 280th meeting held on 29th February & 1st March 2020 considered the matter and as decided, Final Show Cause Notice was issued on 03.03.2020 to the institution on the following grounds:-

- (i) Science faculty is not appointed.
- (ii) Total land area is not mentioned in the Building Plan (BP).

6. AND WHEREAS, the institution has submitted reply vide letter dated 19.03.2020 received in this office on 08.05.2020. The ERC in its 282nd meeting held on 8th & 9th July, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

“Restoration of Recognition Order of B.Ed. course to be issued”.

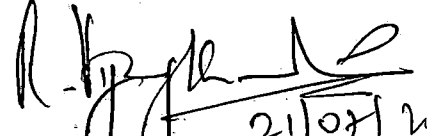

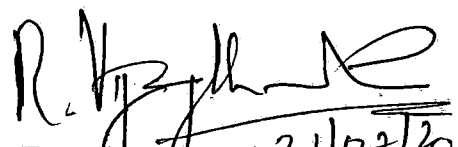
