ORDER

Whereas, the institution N. N. Ghosh Sanatan Teachers Training College, Plot No.- 165, Vill.- Jamuary, P.O.- Kokodro Tehsil/Taluka- Kanke, Town/City- Ranchi, Dist.- Ranchi, Jharkhand- 834006 (Code No. ERCAPP1221) was granted recognition for B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2013-2014 vide ERC's order no. ERC/7-151.6.9/NCTE/B.Ed./ 2013/16578 dt. 02.03.2013.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide ERC's order no. ERC/NCTE/ERCAPP1221/B.Ed.(Revised Order)/2015/32502 dt. 30.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 275th meeting held 27th July, 2019 considered the matter and decided as follows:-

"1st show cause notice u/s 17(1) issued on 17.12.2018, followed by final show cause notice dated 18.06.2019 and the institution is still deficient on the following grounds:-

- (i) Submitted faculty list not approved by affiliating body duly stamped.
- (ii) Faculty list comprises 1+12 instead of 1+15 as per NCTE Regulations, 2014.
- (iii) Faculties at sl. No.5, 10 & 12 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

Accordingly, recognition was withdrawn, u/s 17(1) of the NCTE Act, 1993, vide order no. F.No. F.No.ER-275.14.37/(ERCAPP1221)/B.Ed./2019/61412 dt. 26.08.2019 from the academic session 2020-2021.

- 4. And whereas, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 26.08.2019. The Appellate Authority vide its order no.89-401/E-138243/2019 Appeal/5th Mtg.-2020/4th February, 2020/90103 dt. 11.03.2020 remanded back the case to ERC for revisiting the matter carefully after verifying the qualifications of faculty and approval granted by the affiliating university.
- 5. And whereas, the institution submitted a reply dt. 18.03.2020. The ERC in its 282nd meeting held on 8th & 9th July, 2020 considered the reply of the institution and decided to issue show cause notice and the same was issued on 24.07.2020 to the institution on the following grounds:-
 - (i) A complaint has been received from Dr. Priya Pandey mentioning that she resigned from N.N. Ghosh Sanatan Teachers Training College & presently working m R.T.C. B.Ed. College. Hence, the same name shall be deleted from the proforma.

- (ii) List of revised original teaching faculty duly approved by the Registrar of the concerned affiliating body to be submitted.
- 6. And whereas, the institution submitted reply dt. 23.07.2020, 03.11.2020 & 27.11.2020 and the ERC in its 288th meeting held on 29th January, 2021 considered the reply submitted by the institution alongwith original regulatory file & other related documents, NCTE Act, 1993, Regulations & Guidelines issued by NCTE from time to time and decided as under:-

"Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued."

- Now therefore, recognition withdrawn vide order dt. 26.08.2019 of N.N. Ghosh Sanatan Teachers Training College, Plot No.- 165, Vill.- Jamuary, P.O.- Kokodro Tehsil/Taluka- Kanke, Town/City-Ranchi, Dist.- Ranchi, Jharkhand- 834006 (Code No. ERCAPP1221) for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) is hereby restored from session 2021-2022.
- 8. The terms and conditions of the order No. F. ERC/NCTE/ERCAPP1221/B.Ed. (Revised Order)/2015/32502 dt. 30.05.2015 issued to the institution shall remain same.
