WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Loyola College of Education, Riverview Area, Telco works, Jamshedpur, East Singhbum, Jharkhand – 831004 for conducting B.Ed. programme *vide* order No. 707 dated 31.05.1996 for an academic session 1996-97, followed by recognition order vide F.No.BR-S/E-2/96/6270 dated 22.06.1998 for an academic session 1998-99 for an intake of 80 and order vide No. ERC/7-44/ER-44.5.3/2004/15531 dated 13.05.2004 for additional intake of 20 which makes total intake 80+20=100 and order vide no. F.ERC/NCTE/JH-S/E-2/96-02 & APE00204/B.Ed. (Revised Order)/2015/32698 dated 31.05.2015 with annual intake of 100 students.

- 2. AND WHEREAS, the Show cause notice under section 17 (1) of NCTE Act, 1993 was issued on 04.08.2022 as per decision of 306th meeting of ERC held on 12th to 13th July, 2022 to the all institutions which have not filed PAR on the ground that the institution has breached the condition of recognition as per the provision of Clause 8(12) of NCTE Regulations, 2014 and also clause 7(14)(i) of NCTE, Regulations, 2014 which is related to uploading information on the website.
- 3. AND WHEREAS, the institution has not submitted reply of show cause notice dated 04.08.2022. The matter was again placed before 311th meeting of ERC held on 11th Oct, 2022. The Committee decided that Final Show Cause Notice be issued before withdrawal of recognition under Section 17 of the NCTE Act, 1993 to submit reply within 15 days from the date of issue of Final Show Cause Notice. As per decision of ERC-NCTE, Final SCN was issued to the applicant institution on 20.10.2022.
- 4. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in 316th (virtual) meeting held on 20th December, 2022 by ERC and the Committee observed that the institution has not submitted the reply of First Show Cause Notice dated 04.08.2022 and Final Show Cause Notice dated 20.10.2022 issued to it for non-submission of Performance Appraisal Report (PAR) for the academic session 2020-21. Hence, Committee decided that the recognition for B.Ed. + B.Ed. Add. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.
- 5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Loyola College of Education, Riverview Area, Telco works, Jamshedpur, East Singhbum, Jharkhand 831004 vide order No. ERC/NCTE/ JS-S/E-2/96 & APE00204/ B.Ed (Revised Order)/ 2015/ 32698 dated 31.05.2015 for running B.Ed.
