#### **ORDER**

WHEREAS, Dept. of Education, Dibrugarh University, Dibrugarh, Assam—781316 (File No. AS-SO/E-8/99) was granted recognition for M.Ed. course with an intake of 10 from the academic session 2000-2001 vide ERC Order No.1509 dated 23.05.2001, followed by revised order vide No. 32291 dated 27.05.2015 with an annual intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS**, the ERC in its 278<sup>th</sup> held on 16<sup>th</sup> -18<sup>th</sup> January, 2019 considered the matter and as decided, Final Show Cause Notice u/s 17(1) was issued on 05.02.2020 to the institution on the following grounds:
  - (i) List of teaching faculty is not duly signed by the concerned affiliating body.
  - (ii) Original Building plan (BP) duly signed by the competent authority to be submitted.
  - (iii) Building completion certificate (BCC) in the prescribed format duly signed by the competent authority to be submitted.
  - (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
  - (v) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- 3. **AND WHEREAS**, the ERC in its 282<sup>nd</sup> meeting held on 8<sup>th</sup> & 9<sup>th</sup> July, 2020 considered the matter along with the reply dated 21.02.2020 received in this office on 27.02.2020 submitted by the institution in response to Final Show Cause Notice and observed as under:
  - a) No separate faculty list for M.Ed. Course duly approved by Registrar of the concerned affiliating body submitted.
  - b) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority is not submitted.

In view of the above, the Committee decided as under:

Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.
