**WITHDRAWAL ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to R S Teachers Training College, Plot No. 332, 333, 334, 338, 339, Vill./Po.-Katras Bazar, Tehsil/Taluka-Baghmara, City-Katras, Dist.-Dhanbad, Jharkhand-828114 for B.Ed. programme of one year duration with an annual intake of 100 seats vide order No. ERC/7-160.6.13/NCTE/B.Ed./2013/20578 dated 31.08.2013, followed by issuance of revised recognition order for B.Ed. programme of two year duration with an intake of 100 students (Two basic unit) from the academic session 2015-2016 vide order No. F.ERC/NCTE/ERCAPP1178/B.Ed.(Revised Order)/2015/32601 dt.31.05.2015, as per NCTE Regulations, 2014.

2. AND WHEREAS, the Appeal Committee of the Council vide its order No. F.No.89-95/ E-249519/2022 Appeal/5<sup>th</sup> Meeting 2022/APPLERC202214329/112265 dated 12.07.2022 concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time.

3. AND WHEREAS, the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 313<sup>th</sup> (virtual) meeting and the Committee observed that:-

- The Appeal Committee of the Council vide its Order No.89-95/E-249519/2022 Appeal/5<sup>th</sup> Meeting, 2022/APPLERC20221432 9/112265 dated 12.07.2022 concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time.

The Committee noted that the withdrawal order has already been set aside by the Appellate Authority, therefore, the recognition granted to the Institution for running B.Ed. programme is hereby restored. The Committee further observed that:

- In compliance of the Order, the institution has submitted the documents to the office of ERC.

The Committee noted that:

- The institution has not submitted the certified copy of Fire Safety Certificate duly signed by the competent authority.
- Proof for uploading of documents on the web-site of the institutions as required under clause 7(14(i)) of the NCTE Regulations, 2014 as amended from time to time, is required to be submitted.

- Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months is required to be submitted.

In view of above, the Committee decided Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice.

Accordingly, Show Cause Notice dated 24.11.2022 was issued to the institution.

4. AND WHEREAS, the institution has submitted reply dated 16.12.2022 received in ERC office on 20.12.2022. The matter was placed before 358<sup>th</sup> meeting of ERC held on 06 February 2025 and the committee decided as under:

*"The original file of the institution alongwith other related documents, NCTE Act, 1993, Reply of SCN dated 16.12.2022, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:*

1. The institution is required to submit Fire Safety Certificate issued by the competent authority."

In view of the above, the Committee has decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice on the above deficiencies."

5. Accordingly, Final Show Cause Notice dated 21.02.2025 was issued to the institution.

6. AND WHEREAS, the institution has submitted reply dated 10.03.2025 received in ERC office on 21.03.2025. The matter was placed before 367<sup>th</sup> meeting of ERC held on 04<sup>th</sup> June, 2025 and the committee decided as under:

*"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -*

- The institution has submitted reply to the final show cause notice.

After carefully observing the reply to the final show cause notice, the ERC concluded the following:

- The institution has submitted Fire Safety Certificate dated 23.03.2017 issued by the Karyalaya Aghishthan Agnisham Padadhikari, Dhanbad which is very old.

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

7. NOW THEREFORE, in term of above decision of ERC, the recognition granted tor R S Teachers Training College, Plot No. 332, 333, 334, 338, 339, Vill/Po-Katras Bazar, Tehsil/Taluka-Baghmara, City-Katras, Dist.-Dhanbad, Jharkhand-828114, for running B.Ed. Programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

8. Further the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act:-

9. If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

10. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website [www.ncte.gov.in](http://www.ncte.gov.in) within 60 days from the date of the issue of the order.
