WHEREAS, Govt. Teachers Training College, Hazaribagh, Jharkhand - 825301 (Code No. APE00105) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2002-2003 vide ERC Order dated 20.06.2002, followed by revised order dated 31.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 278^{th} held on $16^{th} 18^{th}$ January 2020, considered the matter and as decided, final show cause notice u/s 17(1) of NCTE Act, 1993. Accordingly, Show Cause notice was issued on 28.01.2020 to the institution on the following grounds:
 - (i) Original list of teaching faculty duly approved by the affiliating body to be submitted.
 - (ii) Building Plan (BP) is not legible. Hence, original Building plan (BP) duly signed by the competent authority to be submitted.
 - (iii) Original Building Completion Certificate (BCC) duly signed by the competent authority to be submitted.
 - (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
 - (v) Website of the institution is not functional as per clause 7(14)(i) of the NCTE Regulation, 2014.
- 3. AND WHEREAS, the institution has not submitted the reply in response to final show cause notice dated 28.01.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 284th meeting held on 17th & 18th September, 2020 and the committee decided as under:-
 - (i) Final show cause notice issued on 05.03.2020 and no reply has been received as on date.

In view of the above, the Committee decided as under:
