ORDER

(72466-72472)

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **Dakshin Dinajpur B.Ed. College, Khasra No. 408, Plot No.75, 78, Vill - Shihur, PO - Tapan, Tehsil/Taluka - Shihur, Town/City - Tapan, Dist. - Dakshin Dinajpur, West Bengal- 733127** was granted recognition for conducting B.Ed. programme of two year duration with an annual intake 50 (one basic unit) vide order No. F.No.ER-250.6.20(Part -1)/ERCAPP3524/B.Ed./2018/56387 dated 03.03.2018 from the academic session 2018-2019, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. The matter was placed before ERC in its 284th meeting held on 17-18 September, 2020 and the Committee decided to issue the Show Cause Notice dated 28.09.2020. The institution has not submitted reply of Show Cause Notice. The matter was placed before ERC in its 303rd Meeting held on 24th March, 2022 and committee decided to issue Final Show Cause Notice dated 09.04.2022. However, the institution has not submitted the reply of Final Show Cause Notice.

3. **AND WHEREAS**, the matter was placed before ERC in its 332nd Meeting held on 30th August, 2023 and committee decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in reference to the Final Show Cause Notice dated 09.04.2022 and the Committee observed that:

- *The institution has not submitted the reply of Final Show Cause Notice dated 09.04.2022 issued to it.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

4. **Accordingly**, Withdrawal Order Vide Order No. F.No. ER-332.28/NCTE/ ERCAPP3524/B.Ed. /WB/2024/68758 Dated 18.09.2023 was issued to the institution.

5. **AND WHEREAS**, The institution preferred appeal before NCTE Appellate Authority against the Order No. 332.28/NCTE/ERCAPP3524/B.Ed./WB/2023/68758 Dated 18.09.2023. In compliance of the appeal order dated 10.10.2023, the institution has submitted reply/documents dated 17.10.2023 received in the office of ERC.

6. **AND WHEREAS**, the matter was placed before ERC in its 329th Meeting held on 13th February, 2024 and committee decided as under:-

"The original file of the institution alongwith Appeal Order, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

- *The Committee noted that the withdrawal order 18.09.2023 has already been set aside by the Appellate Authority vide its Order dated 10.10.2023 and remanded the case back to ERC for*

consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is restored until a fresh withdrawal order is issued by ERC. Order be issued accordingly.

The Committee further decided that the documents submitted by the institution in compliance of the appeal order be verified by the concerned competent authority and a copy of these communications may also be endorsed to the State Government.

7. Accordingly, Restoration Order vide Order No. F.No.ER-339.11/NCTE/B.Ed./ERCAPP3524/B.Ed./WB/2024 Dated 15.02.2024 was issued to the institution.

8. AND WHEREAS, The Institution has filed a Writ Petition No. W.P. (C) 18043/2025, Dakshin Dinajpur D.Ed. College V/S National Council for Teacher Education & Anr before the Hon'ble High Court of Delhi. The Hon'ble Delhi Court has passed an order vide order dated 28.11.2025.

9. AND WHEREAS, the court order passed by Hon'ble High court of Delhi dated 28.11.2025 was placed before ERC in its 384th Meeting held on 09-10th December 2025 and committee decided as under:-

Decision of ERC:

"The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:

- The institution is running B.Ed course vide order No. F.No.ER-250.6.20(Part-1)/ERCAPP3524/B.Ed./2018/56387 dated 03.03.2018 for 50 students in the name of Dakshin Dinajpur B.Ed. College, Khasra No. 408, Plot No.75, 78, Vill- Shihur, PO- Tapan, Tehsil/Taluka - Shihur, Town/City- Tapan, Dist.- Dakshin Dinajpur, West Bengal- 733127.
- Withdrawal Order Vide Order No. F.No. ER-332.28/NCTE/ERCAPP3524/B.Ed./WB/2023/68758 Dated 18.09.2023 was issued to the Institution on certain grounds.
- The institution preferred appeal before NCTE Appellate Authority against the Order No. 332.28/NCTE/ERCAPP3524/B.Ed./WB/2023/68758 Dated 18.09.2023 and the NCTE Appellate Authority decided to remand back the case to ERC with a direction to verify the submitted documents filed by the Appellant institution with Appellate Authority, NCTE from the records available with ERC and if it feels necessary and appropriate then documents may also be verified from the concerned competent authority.
- Restoration Order vide Order No. F.No.ER-339.11/NCTE/ B.Ed./ERCAPP3524 /B.Ed./WB/2024 Dated 15.02.2024 was issued to the institution.
- The Committee further decided that the documents submitted by the institution in compliance of the appeal order be verified by the concerned competent authority and a copy of these communications may also be endorsed to the State Government.
- The Institution has filed a Writ Petition No. W.P. (C) 18043/2025, with request to change of the name of the college from Dakshin Dinajpur B.Ed. College to Dakshin Dinajpur D.Ed. College.
- The Hon'ble High court has passed an order dated 28.11.2025 that "Without entering into the merits of the case, this writ petition is disposed of with the direction to Respondents to treat this writ petition as a representation and pass a decision thereon within two weeks from today. Decision will be communicated to the Petitioner within a week thereafter. It will be open to the Petitioner to take recourse to legal remedies in the event of any surviving grievance.

- *The institution has applied in the name of Dakshin Dinajpur B.Ed College, accordingly the recognition was granted in this name.*

After carefully observing the court order in W.P. (C) No. 18043/2025 passed by the Hon'ble High court of the Delhi along with other related documents submitted while applying for the B.Ed course, the Committee decided to permit the change of the name of institution from Dakshin Dinajpur B.Ed. College to Dakshin Dinajpur D.Ed. College .

The Committee further decided that the documents submitted by the institution in compliance of the appeal order be verified by the concerned competent authority and a copy of these communications may also be endorsed to the State Government. In this regard, reminder letter be issued on top priority.

10 NOW THEREFORE, in terms of the above decision of ERC, name of the institution from Dakshin Dinajpur B.Ed. College, to *Dakshin Dinajpur D.Ed. College* is permitted

Also order that a copy of this Order be published in the Official Gazette.
