ORDER

WHEREAS, Kaliabor College of Education, P.O.-Kuwaritol, Dist. Nagaon, Assam-782137 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7-71.6.8/2006/4964 dated 15.12.2006, followed by revised recognition order No. 31825 dt. 22.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 279th meeting held on 14th 16th February, 2020 considered the matter in its meetings held time to time observed as under:
 - (i) Built up area is less as prescribed in regulation, 2014.
 - (ii) List of teaching faculty namely at Dr. Minati Sarmah Bharati & Mrs. Minaksh Borah are not qualified as per NCTE Regulations, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 26.02.2020. The Appellate Authority vide its Order No. 89-87/E-157926/2020 Appeal/14th Mtg.-2020/28th July, 2020/93140 dated 15.09.2020 decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal order (i) originals of faculty list approved by affiliating body and (ii) B.C.C. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.09.2020, and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 students (02 units) be issued.

- 5. **NOW THEREFORE**, recognition withdrawn vide order dated 26.02.2020 to the institution viz. **Kaliabor College of Education**, **P.O.-Kuwaritol**, **Dist. Nagaon**, **Assam-782137 (APE00454)** for B.Ed. course is hereby restored.
- 6. The terms and conditions of the order No. F. ERC/NCTE/APE00454/B.Ed. (Revised Order)/2015/31825 dt. 22.05.2015 issued to the institution shall remain same.
