ORDER

Whereas, the Govt. College of Physical Education, Kulundi, Sambalpur, Odisha (Code No. OR-S/N-1/2000) was granted recognition for conducting B.P.Ed. course of one year duration with an annual intake of 30 students vide ERC's order no. ERC/7-19/2001/1654 dt 15.06.2001 from the academic session 2001-2002.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide order no. ERC/NCTE/(OR-S/N-1/2000)/B.P.Ed.(Revised Order)/2015/32702 dt. 31.05.2015 for conducting B.P.Ed. course of two years duration for one basic unit of 100 students with two sections of 50 each from the academic session 2015-2016 as per the NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 275th (Part-2) meeting held on 27th July, 2019 considered the matter and decided as follows:-

*1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 21.05.2019 and the institution is still deficient on the following ground:-

(i) Faculty list comprises 1+3, which is less as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course.

Recognition granted to B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021"

Accordingly, recognition granted to the institution was withdrawn u/s 17(1) vide order no. F.No.ER-275.14.89/(OR-S/N-1/2000)/B.P.Ed./2019/61423 dt. 28.03.2019 from the academic session 2020-2021.

- 4. And whereas, the institution preferred an appeal at the NCTE Hqrs. against the withdrawal order dt. 28.08.2019 and the Appellate Authority vide order no.89-121/E-158650/2020 Appeal/17th.Mtg.-2020/1st September, 2020/93561 dt. 29.09.2020 remanded back the case to the ERC for revisiting the matter.
- 5. And whereas, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the reply dt. 07.10.2020 submitted by the institution alongwith the appeal order dt. 29.09.2020, the original file & other related documents in light of the NCTE Act, 1993, NCTE Regulations, Guidelines issued by the NCTE from time to time and decided as under:-

Restoration of recognition order of B.P.Ed. course with an annual intake of 100 (one unit) be issued.

6. Now therefore, recognition of the Govt. College of Physical Education, Kulundi, Sambalpur, Odisha (Code No. OR-S/N-1/2000), withdrawn vide order dt. 28.08.2019, has been restored for conducting B.P.Ed. course of two years duration with an annual intake of 100 students (one unit).
