ORDER

Change of Premises & Restoration of intake

Whereas, Govt. College of Physical Education, Kalinga Stadium, Nayapalli, Bhubaneswar, Odisha-751012 (Code No. OR-SO/N-2/2000) was granted recognition for conducting B.P.Ed. course of one year duration with an annual intake of 64 students vide ERC's order no. ERC/7-18/2001/1416 dt 11.05.2001 from the academic session 2001-2002.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide order no. ERC/NCTE/(OR-SO/N-2/2000)/B.P.Ed.(Revised Order)/2015/32679 dt. 31.05.2015 for conducting B.P.Ed. course of two years duration for one basic unit of 100 students with two sections of 50 each from the academic session 2015-2016 as per the NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 275th (Part-1) meeting held on 26th July, 2019 considered the matter and decided as follows:-

"1s show cause notice w/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 28.11.2018 and the institution is still deficient on the following grounds:-

- (i) Faculty list is not in NCTE Prescribed proforma and not as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course.
- (ii) Building plan and building completion certificate approved by Govt. Engineer are not submitted.

Recognition granted to B.P.Ed. course is withdrawn under section 17(!) of NCTE Act, 1993 from the academic session 2020-2021."

Accordingly, recognition granted to the institution was withdrawn u/s 17(1) vide order no. F.No.ER-275.14.14/(OR-SO/N-2/2000)/B.P.Ed./2019/61454 dt. 30.08.2019 from the academic session 2020 - 2021.

- 4. And whereas, the institution has preferred an appeal at the NCTE Hqrs. against the withdrawal order dt. 30.08.2019 and the Appellate Authority vide order no.89-86/E-158628/2020 Appeal/22nd Mtg.-2020/9th October, 2020/94485 dt. 19.10.2020 remanded back the case to the ERC for expediting inspection of the proposed premises where Government of Odisha proposed to conduct the programme tentporarily.
- 5. And whereas, the institution has also submitted an application dt. 07.01.2020, along with requisite documents, for shifting of premises.
- 6. And whereas, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the reply dt. 07.01.2020 & 04.11.2020 submitted by the institution alongwith the appeal order dt. 19.10.2020, the original file & other related documents in light of the NCTE Act, 1993, NCTE Regulations, Guidelines issued by the NCTE from time to time and decided as under:-
 - 1. Restoration of recognition of B.P.Ed. course be issued.

- 2. Institute is permitted to shift to the NMIET (Narayan Memorial Institute of Engineering and Technology) Campus, Sijua, Sarakantara, Patrapada, Bhubaneswar, Odisha-751019 for a temporary period of 2 years."
- 7. Now therefore, recognition of the Govt. College of Physical Education, Kalinga Stadium, Nayapalli, Bhubaneswar, Odisha- 751012 (Code No. OR-SO/N-2/2000), withdrawn vide order dt. 30.08.2019, has been restored for conducting B.P.Ed. course of two years duration with an annual intake of 100 students (one unit) and permission is granted to the institution to shift its premises from "Kalinga Stadium, Nayapalli, Bhubaneswar, Odisha- 751012" to "Narayan Memorial Institute of Engineering and Technology (NMIET) Campus, Sijua, Sarakantara, Patrapada, Bhubaneswar, Odisha- 751019" for a temporary period of 2 years from the date of issue of this order.

(Pl note:- After the completion of construction / restoration of infrastructure, Institution is required to formally submit an application to the ERC (NCTE) for grant of permission for shitting the institute.)
