#### **ORDER**

WHEREAS, Institute of Advanced Studies in Education, Kunjaban, Agartala, West Tripura, Tripura-799006 was granted recognition for M.Ed. Course with an intake of 20 vide ERC Order No. ERC/7-18/2001/1510(1) dated 23.05.2001 from the academic session 2001-2002, followed by revised recognition order No. 31689 dt. 15.05.2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> 16<sup>th</sup> July, 2019 considered the matter and as decided, recognition granted to M.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-274.14.89/(TR-S/N-1/99)/M.Ed./2019/61170 dated 05.08.2019 from the academic session 2020-2021 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 05.08.2019. The Appellate Authority vide its Order No. 89-196/E-166004/2020 Appeal/22<sup>nd</sup> Mtg.-2020/9<sup>th</sup> October, 2020/94517 dated 19.10.2020 decided that appellant institution is required to submit within 15 days of the issue of appeal order to ERC originals of faculty list, (ii) Building Plan, (iii) Building Completion Certificate (B.C.C.), (iv) Printout of website pages. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 4 AND WHEREAS, the ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 19.10.2020 and the committee decided as under:-

Restoration of recognition order of M.Ed. course with an annual intake of 50 students (01 unit) to be issued.

- 5. NOW THEREFORE, recognition withdrawn vide order dated 03.03.2020 to the institution viz. Institute of Advanced Studies in Education, Kunjaban, Agartala, West Tripura, Tripura-799006 for M.Ed. course is hereby restored recognition with an annual intake of 50 students (01 unit).
- 6. The terms and conditions of the order F. ERC/NCTE/TR-S/N-1/99/M.Ed.(Revised Order)/2015/31689 dt. 15.05.2015 issued to the institution shall remain same.
