ORDER

WHEREAS, in terms of Section 14(3)(a) of the NCTE Act, 1993, **Dept. of Education, Dibrugarh University, Dibrugarh, Assam- 781316** was granted recognition for M.Ed. Course of one year duration with an annual intake of 10 vide ERC Order No.ERC/7-18/2001/1509 dated 23.05.2001, followed by revised recognition order No.F.ERC/NCTE/AS-SO/E-8/99/M.Ed.(Revised Order)/2015/32291 dt.27.05.2015 for M.Ed. course of two year duration with an intake of 50 students from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfillment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 282nd meeting held on 8th 9th July, 2020 considered the matter and as decided, recognition granted to M.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 from the academic session 2021-2022 vide order No.ER-282.21/AS-SO/E-8/99/M.Ed./62819 dated 22.07.2020.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 22.07.2020. The Appellate Authority vide its Order No.89-190/E-165203/2020 Appeal/22nd Mtg.-2020/9th October, 2020/94513 dated 19.10.2020 Appeal Committee decided that appellant university is required to apprise ERC of the action taken to fill up the vacancies so as to keep the strength of faculty adequate separately for the M.Ed. and B.Ed. programme. Appeal Committee further decided to remand back the case to ERC for revisiting the matter both for M.Ed. and B.Ed. programme.
- 4. **AND WHEREAS**, the ERC in its 286th meeting held on 25th–26th November, 2020 considered the appeal order dated 19.10.2020 and decided that show cause notice be issued to the institution. Accordingly, show cause notice dt. 14.12.2020 was issued to the institution on the ground mentioned therein.
- 5. **AND WHEREAS**, the institution has submitted its reply vide letter dt. 06.01.2021 in response to show cause notice dt. 14.12.2020, received on 11.01.2021. The ERC in its 290th (Part -1) meeting held on 3rd March, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice and the Committee decided as under:-

Restoration of recognition order of M.Ed. course with an annual intake of 50 (one unit) be issued.

6. NOW THEREFORE, recognition withdrawn vide order dated 22.07.2020 to the institution viz. Dept. of Education, Dibrugarh University, Dibrugarh, Assam-781316 for M.Ed. course is hereby restored recognition with an annual intake of 50 students (one unit).
